ASSESSING DEMAND FOR CHILDCARE

TOOL-KIT FOR CONDUCTING RESEARCH

1. INTRODUCTION

From April 2007 all Local Authorities (LAs) have a duty to assess the sufficiency of childcare provision in their areas as defined in Section 11 of the Childcare Act 2006. Local Authorities will therefore need to undertake a detailed assessment of the supply of, and demand for, childcare in their area.

To support LAs, the Department for Children, Schools and Families (DCSF, formerly DfES) have produced this tool-kit which outlines the main research issues that need to be considered when assessing parental demand for childcare – whether the research is conducted in-house by professional researchers or is commissioned out to external social researchers.

The tool-kit includes information on:

- sampling,
- strategies for data collection,
- research design,
- analysis and interpretation,
- writing research reports and
- ethics.

2. SAMPLING

2.1 Sample frame

How and from where a sample is drawn will have a direct impact on the credibility of the research and the reliability of the findings. Essentially, findings need to be **generalisable**, which means they should enable general statements about how parents in the local area, use, experience and feel about childcare to be made, and from this enable officials to gauge whether there is sufficient supply. It is possible that some investment in childcare provision might ultimately result from the findings of the research, so it is important to minimise the risk that the findings are due to chance or bias rather than actual differences between different groups in the local population.

• A decision will have to be made on where to draw the sample from. This should be the most comprehensive record of parents, families or children that is available / accessible.

 A random sample from these records will need to be drawn in order to ensure that each person has an equal chance of being contacted to participate in the survey (thereby reducing the risk of bias later on). This will ensure that the responses from people who do use childcare and those who do not are both obtained. Because it is a random sample it should be representative of the population that is being researched¹.

2.2 Sample sizes:

The table below provides a guide to the size of the sample that will be required if simple random sampling methods are being used, in order to ensure the collection of a sufficient amount of data to produce robust and reliable findings.

The following points provide a guide to using the table:

- The numbers given are minimum numbers of responses that are needed to achieve a chosen level of precision. It is likely that some - possibly many - of the people that are approached to participate will decline to do so; and it is therefore advisable to over sample to account for this. Information about expected response rates is given in the following section: 'Strategies For Data Collection'.
- The left-hand column called 'population proportion' asks what proportion of the population is expected to display the attribute under investigation. In this case the local population is all families in the LA and the attribute is whether they use childcare or not. In the absence of this information for a LA, it is recommended that national figures are used as a guide; 64% of families in the last national Parents' Childcare Survey had used childcare in the last week and 36% had not, so a 40%/60% split for the 'population

¹ While there is sometimes a case for other methods of sampling, in this case it might run the risk of sampling people with particular behaviours rather than providing a cross section of the group you are aiming for. We would therefore recommend random sampling for this project.

proportion' column should be assumed. To note, if 36% of families in the national survey had used childcare and 64% had not then the same sample size would be needed for the survey.

- The top row of the table titled 'Precision required (at the 95% confidence level)' requires a decision about what level of precision is required around the resulting survey estimates. Confidence intervals refer to the likelihood that if the research was repeated the same result +/- x% would be achieved. It is recommended that a confidence interval of +/- 3% to +/-5% is used.
 - For example, if it is assumed that 40% of families used formal childcare and a confidence interval of +/- 4% is required, a sample size of 576 responses would be needed.
- The cells highlighted in grey within the table indicate what rows and columns should be read to select the sample size if these assumptions are used.

As a general rule if analysis of sub-groups within the sample is planned, such as respondents living in different areas, or respondents with children in different age groups, each sub-group should contain 50 to 100 cases. See below for more information on boost samples.

2.3 Boost samples

If there are issues of particular relevance to an area (for example out-ofschool provision or early years education) it may be helpful to draw a larger sample or boost the sample of the age groups / areas etc that these issues are known to affect.

Depending on the demographic characteristics of the local area, it may be useful to over sample or boost the sample of a particular age group, income group, ethnic group or other demographic group². However, it may prove too time consuming and costly to achieve a sufficiently high response rate through boosted samples and it may be decided that a qualitative approach would be more effective at accessing the views and experiences of certain groups, particularly if they are less numerous in your local area.

3. STRATEGIES FOR DATA COLLECTION

² For example, there may be particular issues surrounding Early Years provision in your local area, making it sensible to draw a larger sample of people with 3 and 4 year old children to provide enough data for more in-depth / complex analysis.

It is likely that data will be collected using a survey/questionnaire. There are various ways of doing this which include telephone or face-to-face interviews (probably on the doorstep or in participants home), postal or internet survey. While they are potentially more expensive, telephone and face-to-face surveys tend be more reliable as they tend to attract higher response rates and interviewers can be briefed to ensure as consistent an interpretation of the questions as possible (though it is also important to train interviewers to minimise bias and avoid leading respondents when asking questions).

Internet surveys are problematic because only members of the population with access/regular access to a computer will be able to participate, and there is less certainty of who completed the survey. Postal surveys typically have a much lower response rate.

4. RESEARCH DESIGN ISSUES

The clarity of the questions in the survey will have a direct impact on the clarity of the responses obtained for analysis. Survey questions need to be as clear and direct as possible in order to minimise the amount of interpretation respondents will engage in with regard to what the question is asking. Large surveys incorporate a stage of cognitive testing prior to piloting (whereby questions are put to participants who are also asked how they interpreted the questions and what their answer meant to them) to ensure that respondents are interpreting and answering questions in as similar a way as possible. Two common mistakes are illustrated in the following example:

- Do you use childcare and early years providers a lot?
 - Firstly, the term 'a lot' is vague and may be interpreted differently from one person to the next. Where one might interpret it as asking about regularity of use (i.e. monthly/weekly) another might interpret it as asking about frequency of use, while others still might think they are being asked about how many different providers they use?
 - Secondly, if someone responds 'yes' are they talking about using early years services, childcare services or both?

5. SURVEY QUESTIONS

The National Centre for Social Research (NatCen) has undertaken national surveys of parents use, views and experiences of childcare, on the behalf of the DCSF.

Many of the questions used in these surveys will also be applicable at a local authority level. The questions on the national survey have been subject to cognitive testing and piloting and have already been used in the field. Using these existing questions would ensure that the LA survey questions were clear and direct, without the need for LAs to run their own question testing.

Using the existing questions would also give LAs the opportunity to compare the results for their area with the national and regional figures, allowing areas to see how they are performing compared to these benchmarks.

NatCen have developed an abridged version of the national survey for use by LAs.

A copy of the abridged questionnaire, showcards and guidance on its use are attached at Annexes A, B and C.

It is estimated that this abridged survey would take around 10-15 minutes for a respondent to complete, although the length of the interview would be affected by the number of children in the household and the number of childcare providers used.

LAs may want to include additional questions to those on the abridged survey, for example a LA may also want to collect information on the working patterns of the household and when childcare is needed, the reasons why childcare is used, or how people find out about childcare in their area. Many of these areas are covered in the national surveys of parents which could be used as a starting point for LAs to develop further questionnaire topics.

It is important to consider in detail what information is needed and what it will be used for before adding questions to the survey. For example, if respondents are asked whether they want childcare near their home or place of work it may also be useful to ask for the postcode of their home or workplace if the LA intends to use this information to select the locations for new childcare providers.

6. ANALYSIS AND INTERPRETATION

Analysis can range from looking at cross-tabulations of data and drawing conclusions from the proportions of each group giving a particular response to extremely complex statistical analysis that calculates the strength and significance of certain factors on the behaviour or attitudes of participants. If the research is being conducted in-house, this stage will require the involvement of statistical analysts. If the research is being commissioned to an external contractor it would be advisable to ensure that your internal

statisticians quality assure the analytic process and read through the final drafts to check for accuracy and clarity.

LAs may want to compare their results with those from the national survey to see how they are performing compared to the national and regional benchmarks.

Further national results which LAs may want for benchmarking are attached at Annex D.

7. WRITING RESEARCH REPORTS

Research reports should aim to be as clear and succinct as possible, avoiding over-wordiness and unnecessarily long or complicated words. Research reports should be easily understandable to a lay-person; the comprehensibility of a report should be checked at the draft stage and revised accordingly.

Reports should not be overly complicated and - except for where there is a high degree of certainty or empirical evidence which substantiates claims should avoid trying to give reasons/explanations for all findings. Often research opens up new avenues of enquiry and raises as many questions as it answers. Avoid the temptation to 'pad out' the report with information that was not gathered through the data collection on which the report is based.

It is also advisable to circulate drafts among policy and research colleagues who may be able to suggest different approaches to analysis according to their particular policy interest or analytic knowledge. This will enable a broader range of people to comment on clarity of presentation as well.

8. ETHICS, CONFIDENTIALITY AND ANONYMITY

When undertaking any research project, due consideration must be given to ethics. Researchers acknowledge a commitment to avoid discouraging participants from taking part in future research, and a primary concern is therefore to ensure no damage (emotional, physical, psychological or social) or negative repercussions are experienced by any participants as a result of the research. While many of the issues relating to parents' demand for childcare are unlikely to be considered 'sensitive' certain issues (e.g. family income) may well be considered sensitive by some respondents. The privacy of respondents must be respected and it should be borne in mind that some participants may be more vulnerable than others.

The key to good research is to encourage participants to give their true opinions about the topic, however unpalatable these may be. People are more likely to do this if they are confident that there will not be any adverse effects of this (for example, a respondent may be reluctant to be openly critical of a childcare setting which their child attends). Confidentiality must therefore always be explained and guaranteed.

It is useful to keep in mind that respondents will be participating on a voluntary basis and are therefore doing the LA a favour – even if the research stands to benefit parents in the future.

Key issues to consider are:

- **Anonymity** most research will not require the details of participants to be linked to data, and will guarantee that participants' identities will not be divulged in the report. As this research is taking place at a local level, there is a need to give particular attention to this. Given a little knowledge of an area, it is surprisingly easy to link apparently abstract data to a particular location or person.
- **Confidentiality** it is important that participants understand that researchers will not discuss their contributions with people outside the research process and that information participants provide will be appropriately anonymised.
- Informed consent potential participants should be given details of the purpose of the project and of what is required of them as participants, i.e. how long the interview will take; that it is voluntary and they can withdraw their consent at any time (prior to anonymisation); that it will be confidential and anonymous. Participants should also be given an opportunity to have any questions they might have answered
- **No pressure** it is important that, if potential respondents decline to participate, they are not coerced or pressured into changing their minds.

This document provides guidance on how to use an abridged version of the Childcare and Early Years Survey questionnaire, which focuses on the recommended areas for the local authority sufficiency assessments. The areas included can be found in the table below.

How you, as a local authority, decide to use this document will depend on the nature of the survey that you are intending to undertake. For instance, you may wish to omit sections of the questionnaire that you do not wish to cover. Similarly, the questionnaire may not include all of the areas that you do wish to cover, in which case you will need to draft your own questionnaire sections.

Additional areas that you may wish to add include:

- Area of residence
- Preferred type of childcare provider
- Times where childcare unavailable
- How patterns of childcare use would change if cost increased or decreased
- Timeliness of local childcare
- Accessibility of local childcare

Finally, depending on the research questions that you wish to answer – you may need to combine the answers to more than one question, or undertake some calculations. Some instances of this are included in the "manipulation required" column in the table above, e.g. to look at the hourly cost of childcare, it would be necessary to use the information from Question 15 (cost of childcare in the week) and Question 13 (number of hours children attended childcare in the week). Another example might be a wish to look at childcare that a family used in the last year, in which case it would be necessary to combine the answers to Question 11 and Question 18.

The Questionnaire

In addition to abridging the questionnaire, its presentation has been modified under the assumption that most local authorities will be conducting surveys using 'pen and paper' interviewing (whilst the Childcare and Early Years Survey is conducted using 'computer assisted' interviewing).

• All the questions have been given a number and these all appear in **bold** e.g. **Question 1**.

Reading questions

- Interviewers should read all the text that is in Title Case. Any text that is in CAPITALS is a note to the interviewer only, and should not be read out.
- When reading questions: phrases or words in *[italics and square brackets]* indicate places where the interviewer will need to decide what to say e.g. *[and your partner]* would mean that the interviewer should see whether the respondent has a partner and say this phrase only if appropriate. Similarly *[child's name]* would mean that the interviewer should say the name of the child the question is currently referring to.

Recording answers to questions

- The instruction <u>CODE ALL THAT APPLY</u> indicates a multi-coded question and more than one answer is permissible. If this is not stated then the question should be single code, meaning that only one answer should be given.
- In most instances answers should be recorded by circling the answer given by the parent. However there are also 2 parts of the questionnaire where a set of questions need to be asked a number of times. These are the questions about children in the household and childcare providers used by the parent. The start of these sets of questions are identified by a text box that says:

"Start of Questions for Children Table" "Start of Questions for Childcare Provision Table"

Similarly the end of these sets of questions are identified by a text box that says:

"End of Questions for Children Table" "End of Questions for Childcare Provision Table"

For these questions, the answers should be entered in a table found at the end of the document. This is highlighted by an instruction that says:

ENTER ANSWER IN THE TABLE

Deciding which questions to ask

- Since not all questions should be asked of all people (and as explained above, some need to be asked more than once), directions relating to which question the interviewer should ask next are found to the right of the answers e.g.
 - 1. Yes \rightarrow GO TO Question 2
 - 2. No \rightarrow GO TO Question 3

Where there are no instructions to the right of the answers, the interviewer should just ask the next question.

In addition, a description that explains when each question needs to be asked can be found above the question number in *{italics and curly brackets}* e.g.
