The Scottish Government recently released the 2014 data for the provision of respite in Local Authority areas across Scotland. The statistics are presented in "respite weeks provided or purchased by local authorities" and then further broken down into "overnight" and "daytime" respite for three age groups: 0-17, 18-64 and 65+. Much of the data is only comparable on a year-to-year basis due to methodological changes that have taken place over time. However a number of helpful comparisons are possible.

According to Scottish Government figures the overall amount of Respite Weeks delivered in 2013/2014 fell by 1,990 weeks compared with the previous year. The report states that changes in how respite weeks are recorded, and the shift to individually arranged breaks using Self-directed Support, is making comparisons more difficult.

However, the Report concludes that... 'In terms of understanding the origin of the estimated real terms decrease in respite provision over the past year, it is thought that the likely combined effect of the known recording changes is to mask a somewhat larger real terms decrease in service provision.¹




Chart 1 - Estimated real terms changes in the provision of overnight and daytime respite weeks in Scotland, 2007/08 to 2013/14

In total 13 local authority areas reported decreases in respite weeks last year with the largest decrease coming from Glasgow (-23%). Were all the figures for Glasgow to be excluded from the Scotland level estimates this would result in an increase of 2,810 weeks between 2012/2013 and 2013/2014 rather than a decrease of 1,990 weeks.

Despite the drop in weeks last year, the report concludes the total overnight and daytime respite provision recorded in 2013/14 *continues to represent an estimated real terms increase of 10,650 respite weeks (6.2%) on 2007/08*['].

Shared Care Scotland's Response

We appreciate the considerable effort that goes into producing this data both at the local authority level and within Scottish Government. The purpose is to monitor progress against the government's 2008 national commitment to deliver and maintain an additional 10,000 weeks of respite care across Scotland. These additional weeks are measured against a baseline figure calculated in 2007/2008.

Announcing this commitment at the time, then Health Minister Shona Robison said:

"It is of great importance that we support those who selflessly give their time to support a loved one. We need to ensure that carers do not neglect their own health and are able to take short breaks when they need them."

However, it is interesting to consider the demographic changes that have happened over the intervening years. If we factor in the population changes that have taken place a different picture emerges.

From our analysis of the data we have produced the following table to take account of these changes in each age category. The right hand column shows the resultant net change in respite weeks since 2007/2008.

Taking account of population changes the table shows a reducing level of respite in each age category pro rata and an effective overall net loss of 1,814 weeks since 2007/2008 compared to the published additional 10,650 weeks. This application of the data perhaps provides an additional and somewhat different picture of what is happening on the ground.

Going forward we would therefore urge national and local government to keep under review its short breaks policies and funding. They must ensure there is an adequate level of response to deliver the promised improvements in respite care, and that these keep pace with demographic changes. As the Minister said when launching the manifesto commitment,

"As we see Scotland's demographic change and people living longer, this becomes an even greater issue with the role of carers very much at the fore."

The wide variation in levels of provision continues to be a concern. 11 out of 32 local authorities are reporting less respite care than measured 6 years ago when the commitment was introduced. This suggests carers and the people they care for continue to experience a 'postcode lottery' when it comes to accessing much needed breaks. This needs to be addressed. All local authorities received additional central government funding in return for their commitment to this target and should therefore be accountable.

If local authorities are reporting less weeks as a result they say of undercounting certain provision in annual returns, or because local demand for breaks is reducing, then this needs to be carefully justified. All local authorities must of course be transparent with carers and families about how they measure improvements in respite care, and publish evidence to back this up.
