



## Ailystyried Seibiant ar gyfer Pobl a Effeithir gan Dementia

### Annex 2: Llyfryddiaeth

Cafodd yr adolygiad llenyddiaeth ei wneud gan Gymdeithas Astudiaethau Dementia Prifysgol Caerwrangon rhwng mis Hydref 2018 a mis Rhagfyr 2018.

**Cam 1:** Cynhaliwyd chwiliad cyffredinol yn llyfrgelloedd y Brifysgol Agored a Phrifysgol Caerwrangon a Google/Google Scholar i asesu'r sefyllfa o ran llenyddiaeth academaidd a oedd yn ymwneud â seibiant. Man cychwyn yr adolygiad llenyddiaeth oedd ystod o adolygiadau systematig o'r pum mlynedd diwethaf, gan fod yr adolygiadau hyn yn adlewyrchu'r llenyddiaeth dros gyfnod o oddeutu 20 mlynedd.
