Executive summary

Introduction

The Scottish Crime and Justice Survey (SCJS) is a large-scale continuous survey measuring people's experience and perceptions of crime in Scotland, based on 16,000 in-home face-to-face interviews conducted annually with adults (aged 16 or over) living in private households in Scotland. The results are presented in a series of reports including this one which provides information on partner abuse.

The SCJS 2008-09 focuses specifically on abuse carried out by a partner or ex-partner. The definition of partner used in the questionnaire included any boyfriend, girlfriend, husband, wife or civil partner. Partner abuse as defined in the SCJS 2008-09 includes psychological and physical forms of abuse. The definition of psychological abuse includes emotional, financial and other forms of psychological abuse. The definition of physical includes sexual and other forms of physical abuse.

This report identifies the extent of partner abuse, both since the age of 16 and in the last 12 months. It examines the nature and impact of partner abuse and explores the extent to which people or organisations were informed about the abuse, including specifically contact with the police about the incident.

The extent of partner abuse

18% of those who had at least one partner since the age of 16 had experienced one of the forms of partner abuse as measured by the SCJS in 2008-09 since the age of 16. Five per cent of those who had a partner or were in contact with an ex-partner in the last 12 months reported experiencing at least one form of partner abuse in the last 12 months. This included four per cent who said they had experienced psychological partner abuse in the last 12 months and three percent who had experienced physical partner abuse in the last 12 months.

A similar percentage of males and females experienced partner abuse in the last 12 months (both five per cent). Partner abuse was more likely to be experienced by those aged 16-24 (13%); victims of other crimes (10%) and those living in the 15% most deprived areas of Scotland (10%).

For 45% of those experiencing any form of partner abuse in the last 12 months this had happened once and for 11% it had happened twice. Three per cent of those experiencing partner abuse in the last 12 months said there were too many incidents to count in that period and 27% said they did not want to answer or they did not know / could not remember how many incidents they had experienced in the last 12 months.

The nature and impact of partner abuse

More than eight in ten (83%) of those experiencing any form of partner abuse since the age of 16, experienced psychological abuse. A higher percentage of women (91%) said they had experienced at least one form of psychological

abuse than men (71%) since the age of 16. On average women had experienced over three forms while men had experienced between one and two of the forms of psychological abuse since the age of 16.

The main types of psychological abuse experienced since the age of 16 included a partner behaving in a jealous or controlling way (53%); repeatedly putting them down so they felt worthless (42%); threatening to hurt them (31%) or stopping them from seeing friends or relatives (28%).

More than seven in ten (72%) of those experiencing any form of partner abuse since the age of 16, experienced physical abuse. A similar percentage of women (73%) and men (71%) who experienced any form of partner abuse since the age of 16 said they had experienced at least one form of physical abuse since the age of 16.

The main types of physical abuse experienced since the age of 16 included a partner throwing something at them (50%); kicking, biting or hitting them (36%) or pushing or holding them down (33%).

The majority (70%) who had experienced at least one form of partner abuse, either psychological or physical, since the age of 16, had just one abusive partner. One in five (22%) had more than one abusive partner since that age.

In the majority of cases, where partner abuse was experienced since the age of 16, the gender of any abusive partner was male (60%) compared with 38% where the gender of any abusive partner was female. Among those experiencing partner abuse in the last 12 months, in the most recent / only incident, 48% of offenders were male and 45% female.

30% experiencing any of the forms of physical abuse in the last 12 months considered what happened on the most recent / only occasion to be a crime compared with 22% of those experiencing any psychological abuse.

Nine per cent of adults who had a partner since the age of 16 considered they had been a victim of domestic abuse (self-defined) since that age, lower than the 18% who said they had experienced at least one form of psychological or physical abuse as measured by the SCJS 2008-09. Women (14%) were more likely to consider themselves to have been a victim of domestic abuse than men (three per cent).

Reporting incidents of partner abuse

Almost two-thirds (64%) of those experiencing partner abuse in the last 12 months had told at least one person or organisation about the most recent / only incident they experienced. This was most often a friend (37%) or a relative (25%).

Around three in ten (31%) did not tell anyone about the most recent / only incident of partner abuse experienced in the last 12 months. This was higher for men (40%) than for women (21%).

The police came to know about one in five (21%) of the most recent / only incidents of partner abuse experienced in the last 12 months. This was higher for the most recent / only incident experienced by women (35%) than by men (eight per cent).

Where police came to know about the incident, just over half (53%) were satisfied with the way the police dealt with the most recent / only incident experienced in the last 12 months. Over a third (35%) were dissatisfied.

1 Introduction

The Scottish Crime and Justice Survey (SCJS)¹ is a large-scale continuous survey measuring adults' experience and perceptions of crime in Scotland. The survey is based on, annually, 16,000 in-home face-to-face interviews with adults (aged 16 or over) living in private households in Scotland.

The main aims of the SCJS are to:

- Provide a valid and reliable measure of adults' experience of crime, including services provided to victims of crime;
- Examine trends in the number and nature of crime in Scotland over time;
- Examine the varying risk of crime for different groups of adults in the population;
- Collect information about adults' experiences of, and attitudes to, a range of crime and justice related issues.

The first findings for 2008-09 are presented in a series of four reports. This report presents the key findings about partner abuse collected through the self-completion section of the SCJS 2008-09. Separate technical reports are also available.²

1.1 Partner abuse in the SCJS 2008-09

The definition the police use in statistics of domestic abuse recorded by them is:

"...any form of physical, non-physical, or sexual abuse which takes place within the context of a close relationship, committed either in the home or elsewhere. This relationship will be between partners (married, co-habiting or otherwise) or ex-partners.'

Like the police definition, the SCJS 2008-09 focuses specifically on abuse experienced since the age of 16 carried out by a partner.³ This is referred to throughout this report as partner abuse. It includes abuse undertaken by and against both men and women. Police statistics demonstrate that, while women were victims in 85% of reported incidents of domestic abuse year-on-

year there have been an increasing number of men reporting experiences of domestic abuse.⁴

Information on experience of partner abuse was collected through the self-completion section of the questionnaire. Partner abuse as defined in this report includes psychological and physical forms of abuse. This definition has been broadened compared with the 2005-06 Scottish Crime and Victimisation Survey (SCVS). Differences between the SCJS 2008-09 and the SCVS 2005-06 in the questions used to define partner abuse, the length of reference period used for the more recent experiences and the age range of those answering the self-completion questionnaire means trends cannot be identified by comparing the two surveys (annex 2).

Violent crime is identified in the SCJS 2008-09 as solely including physical violence. Recognising the difference in these definitions, comparisons are drawn at various points in the report between partner abuse, as measured in the self-completion questionnaire, and violent crime, as measured though the victim form in the main questionnaire, to set the results within the broader context of violent crime in Scotland.⁵

1.2 The structure of the report

This chapter has provided an overview of the SCJS 2008-09, specifically of the partner abuse section of the questionnaire.

Chapter 2 examines the risk and extent of partner abuse. It starts by establishing the proportion of adults who have had a partner since the age of 16 and in the last 12 months. The risk of partner abuse and the variation in that risk faced by different groups of adults is then described and the number of incidents of partner abuse experienced is presented. The chapter ends by briefly examining links between partner abuse and stalking (a separate series of questions within the self-completion questionnaire).

Chapter 3 includes details about the nature and impact of the partner abuse. It starts by examining the forms of psychological and physical abuse experienced. It then examines the characteristics of the offending partners of abused adults and explores the presence of children in the household and their involvement, if any, in the most recent / only incident. The impacts of this incident on the adult experiencing it and their opinions of it are then highlighted. Finally the views of all adults on whether they had been the victim of domestic abuse are examined.

Chapter 4 provides information about reporting / informing others about incidents of abuse. Firstly it describes who the adult experiencing it told about the most recent / only incident of abuse. It then focuses on reporting to the police, including whether the incident was reported at all; if it was not, why not, and if it was, how satisfied the abused adult was with how the police handled the matter.

Annex 1 contains additional data tables showing the percentage experiencing partner abuse as measured by the SCJS in 2008-09 since the age of 16 and in the last 12 months by a range of demographic, experiential and geographic variables. It also provides estimates, in total and broken down by gender, of the number of adults aged 16 or over who had at least one partner since the age of 16 and who had or had not experienced partner abuse since that age and of the number of adults aged 16 or over who had a partner or had contact with an ex-partner in the last 12 months and who had or had not experienced partner abuse in the last 12 months.

Annex 2 provides information on the method used in the SCJS 2008-09, specifically the self-completion questionnaire. This includes some information on the domestic abuse questions in the questionnaire and how they were developed. It also provides information on the self-completion interview, and the weighting used in the analysis of the results.

2 The extent of partner abuse

2.1 Summary

Since the age of 16, 18% of those who had at least one partner had experienced one of the forms of partner abuse and five per cent of those who had a partner or were in contact with an ex-partner in the last 12 months reported experiencing at least one form of partner abuse in the last 12 months. This included:

- Four per cent who said they had experienced any of the forms of psychological partner abuse in the last 12 months;
- Three percent who had experienced any of the forms of physical partner abuse in the last 12 months.

Experience of partner abuse in the last 12 months was similar for males and females (both five per cent) and was higher for:

- Younger adults aged 16-24 (13%);
- Victims of other crimes (10%);
- Those living in the 15% most deprived areas of Scotland (10%).

For 45% of those experiencing any form of partner abuse in the last 12 months this had happened once and for 11% it had happened twice. Three per cent experiencing partner abuse in the last 12 months said there were too many incidents to count in that period and 27% said they did not want to answer or they did not know / could not remember how many incidents they had experienced in the last 12 months.

2.2 Introduction

This chapter looks at the extent of partner abuse among adults in Scotland as measured by the SCJS in 2008-09. It covers:

- The overall risk of experiencing partner abuse, including the percentage who experienced at least one incident since the age of 16 as well as in the last 12 months;
- How the risk of partner abuse in the last 12 months varied by different demographic, experiential and socio-economic sub-groups;
- The frequency of partner abuse, looking at the number of incidents measured in the SCJS in 2008-09 experienced in the last 12 months.

2.3 Presence of partner

By definition, partner abuse can only occur where a partner is present in someone's life. Therefore, at the start of the abuse section, adults were asked if they had a partner since the age of 16 and in the last 12 months.

Almost all adults (92%) reported having had a partner at some stage since they were 16 and 70% reported having had a partner or contact with an expartner in the last 12 months.

Only those who have had a partner at all since the age of 16 were asked the questions on experience of partner abuse and therefore only this group of adults were included in the analysis for this report. In some instances the report presents data on partner abuse since the age of 16, though the majority of the report focuses on abuse happening in the last 12 months. Where abuse in the last 12 months is examined in more detail, information was collected about the most recent / only incident experienced in that period.

2.4 Risk of partner abuse

Five per cent of those who had a partner or were in contact with an ex-partner in the last 12 months reported experiencing at least one form of partner abuse in that period as measured by the SCJS in 2008-09. As Figure 2.1 shows, the risks of experiencing psychological or physical abuse were similar:

- Four per cent of adults who had a partner or were in contact with an ex-partner in the last 12 months said they had experienced psychological abuse, including mental, emotional or financial abuse;
- Three per cent of adults who had a partner or were in contact with an ex-partner in the last 12 months had experienced physical abuse, including sexual abuse.

In order to provide a more general picture of the risk of partner abuse, adults were also asked whether they had experienced partner abuse since the age of 16 (Figure 2.1). Of those who had a partner since the age of 16:

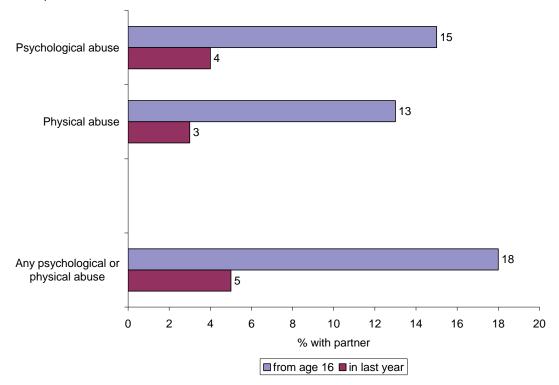
- Overall, almost two in ten (18%) had experienced at least one incident of abuse from a partner;
- 15% had experienced at least one incident of psychological abuse;
- 13% had experienced at least one incident of physical abuse.

One in ten (10%) adults who had a partner since the age of 16 had experienced both psychological abuse and physical abuse from a partner since that age. Two per cent of adults had experienced both forms of abuse in the last 12 months.

Trends in the estimates of the prevalence of partner abuse cannot be identified due to differences between the SCJS 2008-09 and the SCVS 2005-06 as described in annex 2.

2.5 Variation in risk

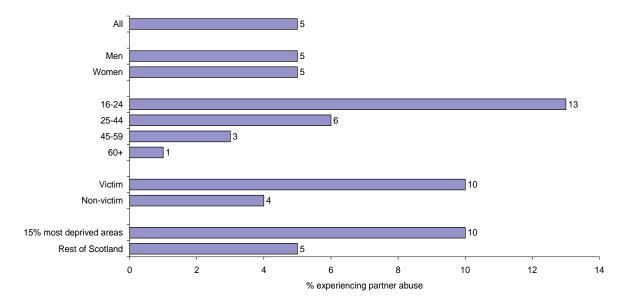
This section explores how the risk of experiencing partner abuse as measured by the SCJS 2008-09 varies on average among different groups of adults in Scotland. However, the analysis only presents simple one-to-one relationships based on demographic, experiential or area characteristics, rather than more complex inter-relationships that might be identified through statistical modelling. Further details of the percentages of different sub-groups experiencing partner abuse are presented in annex 1.

Among adults who had a partner in the last 12 months there was no difference between men or women in the proportion experiencing partner abuse. Figure 2.2 shows differences in the risk of partner abuse in the last 12 months among the other sub-groups:

- Younger adults were more likely to have experienced abuse by a partner in the last 12 months, with rates varying from 13% of 16-24 year olds experiencing psychological or physical abuse to one per cent of those aged 60 or older;
- Those who were victims of at least one crime as measured through the main SCJS 2008-09 questionnaire were more likely to have experienced partner abuse (10%) than were those who had not been the victim of at least one such crime (four per cent);
- Experience of partner abuse also differed by deprivation level, with a higher risk to adults in the 15% most deprived areas of Scotland compared with the rest of Scotland (10% and five per cent respectively).⁷

In general variations in risk were similar both for partner abuse in the last 12 months and since the age of 16, although some differences were evident:

 A significant gender divide was evident when looking at all experiences since the age of 16. For example, over one in five (21%) women said they had experienced any psychological or physical abuse as

measured by the SCJS in 2008-09 compared with one in seven (15%) men:

- Experience of any form of partner abuse since 16 was similar for those aged 16-24 and 25-44 (24% and 25% respectively). Thereafter the percentage decreased to 19% of 45-59 year olds and seven per cent of those aged 60 or over;
- Examining the combined effects of age and gender showed that woman aged 25-44 were at significantly greater risk of experiencing partner abuse as measured by the SCJS in 2008-09 since the age of 16 than males of the same age and females overall (30% compared with 19% of males of the same age and compared with 21% of females overall).

It might have been expected that older people would have reported a greater risk as they have had more years in which to experience partner abuse since the age of 16. In fact, higher levels of partner abuse were reported by younger adults. There are a number of reasons why this might be the case. For example it could be due to increased recognition of different forms of behaviour as unacceptable among younger adults or to increased willingness of younger adults to acknowledge partner abuse had occurred. Alternatively it could signal an increase in partner abuse over time. Another reason might be the way respondents answer some time-based questions, with those experiencing abuse in the more recent past more likely to say they have had the experience since the age of 16 than those whose experience of abuse was longer ago. Further research would be required to establish the particular reasons for the age effects reported here.

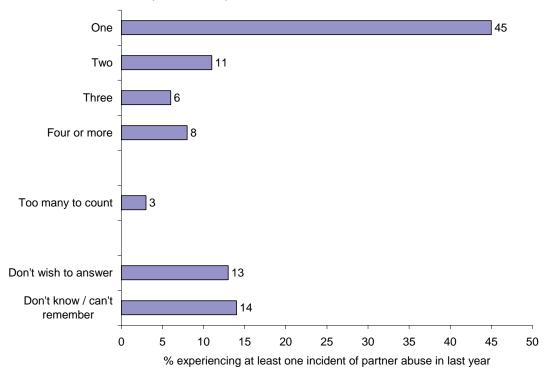
2.6 Number of incidents experienced

Those experiencing any form of partner abuse as measured by the SCJS 2008-09 in the last 12 months were asked how many incidents they had experienced in that time (Figure 2.3).

- The majority of adults experiencing partner abuse in the last 12 months said the abuse occurred only once or twice (45% and 11% respectively) in the last 12 months. The proportion saying this had happened once was higher for men (52%) than for women (37%);
- For six per cent, partner abuse happened three times in the last 12 months while for eight per cent it had happened four or more times;
- A small proportion of adults who had experienced partner abuse in the last 12 months (three per cent) said it had happened too many times to count:
- In addition, almost three in ten did not answer the question saying they did not wish to answer (13%) or did not know / could not remember (14%). The proportion saying they did not know / could not remember was higher for women (18%) than for men (10%).

2.7 Stalking and harassment by (ex) partners

The SCJS 2008-09 also asked separately about incidents involving stalking and harassment, which, if perpetrated by the partner or ex-partner of the adult experiencing it, may be part of a course of conduct alongside other forms of partner abuse. Forms of stalking or harassment measured in the SCJS 2008-09 included: unwanted correspondence; obscene telephone calls; someone waiting outside or being followed.⁹

Of all adults (including those who had not been in a relationship in the period) six per cent had experienced some form of stalking and harassment in the last 12 months. The risk of experiencing any form of stalking and harassment was broadly the same for those who had a partner or contact with an ex-partner in the last 12 months (seven per cent). Examining the links between partner abuse and stalking and harassment in more detail showed:

 Among those who had experienced partner abuse in the last 12 months, 33% had also experienced stalking and harassment in the last 12 months;

3 The nature and impact of partner abuse

3.1 Summary

More than eight in ten (83%) of those experiencing any form of partner abuse since the age of 16, experienced psychological abuse.

- A higher percentage of women (91%) said they had experienced at least one form of psychological abuse than men (71%) since the age of 16;
- On average women had experienced over three forms while men had experienced between one and two of the forms of psychological abuse since the age of 16.

The main types of psychological abuse experienced since the age of 16 included a partner behaving in a jealous or controlling way (53%); repeatedly putting them down so they felt worthless (42%); threatening to hurt them (31%) or stopping them from seeing friends or relatives (28%).

More than seven in ten (72%) of those experiencing any form of partner abuse since the age of 16, experienced physical abuse.

• Of those people who reported experiencing any form of partner abuse since the age of 16, a similar percentage of women (73%) and men (71%) said they had experienced at least one form of physical abuse since the age of 16.

The main types of physical abuse experienced since the age of 16 included a partner throwing something at them (50%); kicking, biting or hitting them (36%); pushing or holding them down (33%).

The majority (70%) who had experienced at least one form of partner abuse, either psychological or physical, since the age of 16, had just one abusive partner. Over one in five (22%) had more than one abusive partner since that age.

Examining the gender of perpetrators:

- In the majority of cases, where partner abuse was experienced since the age of 16, the gender of any abusive partner was male (60%) compared with 38% where the gender of any abusive partner was female;
- Among those experiencing partner abuse in the last 12 months, 48% of offenders were male and 45% female.

30% of adults experiencing any of the forms of physical abuse in the last 12 months considered what happened on the most recent / only occasion a crime compared with 22% of those experiencing any psychological abuse.

Nine per cent of adults who had a partner since the age of 16 considered they had been a victim of domestic abuse (self-defined) since that age compared with 18% who said they had experienced at least one form of psychological or physical abuse as measured in the SCJS 2008-09. Women (14%) were more likely to consider themselves to have been a victim of domestic abuse than men (three per cent).

3.2 Introduction

This chapter looks in more detail at the specific nature of abuse experienced by adults, covering:

- The forms of psychological or physical partner abuse experienced since the age of 16;
- How many abusive partners adults experiencing abuse have had since the age of 16;
- Whether the abused adult was living with their partner at the time of the most recent / only abuse in the last 12 months and at the time of the interview;
- The gender of the offender in partner abuse experienced since the age of 16 and for the most recent / only incident in the last 12 months;
- The presence and involvement of children for the most recent / only incident experienced in the last 12 months;
- The impact on the abused adult of the most recent / only psychological or physical incident experienced in the last 12 months;
- Perceptions of the most recent / only incident of partner abuse experienced in the last 12 months and of adults' experiences of domestic abuse more generally since the age of 16.

3.3 Form of abuse experienced – psychological abuse

As discussed in section 2.4 above, 15% of adults who had a partner since age 16 had experienced psychological abuse (mental, emotional or financial) from a partner since that age. This section looks at these instances of psychological abuse by a partner since the age of 16 in more detail.

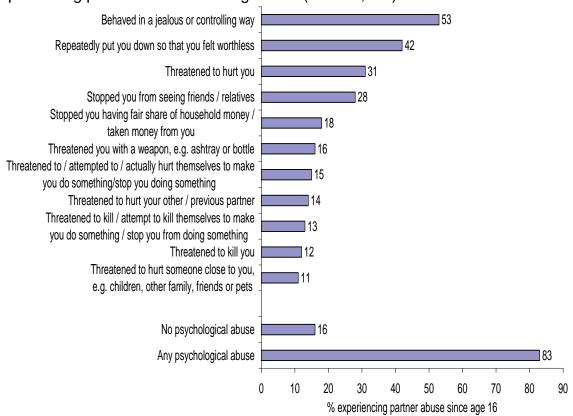
More than eight in ten (83%) of those experiencing any form of partner abuse experienced psychological abuse (Figure 3.1). On average those experiencing any psychological abuse since the age of 16 mentioned between two and three forms of abuse. For example:

• Over five in ten (53%) of those experiencing any form of partner abuse since the age of 16 said their partner behaved in a jealous or controlling way and four in ten (42%) said their partner repeatedly put them down so they felt worthless:

- Around three in ten of those experiencing any form of partner abuse since the age of 16 said their partner threatened to hurt them (31%) or stopped them from seeing friends or relatives (28%);
- Almost two in ten (18%) of those experiencing any form of partner abuse since the age of 16 said that money had been withheld or taken from them;
- Other psychological abuse focused on threats of force or violence against the abused adult, their current or a previous partner, other people or animals close to them and, in some cases, the perpetrator themselves. These were experienced by 16% or fewer adults experiencing any form of partner abuse.¹⁰

Among adults experiencing partner abuse since age 16, women were more likely to have experienced any of the forms of psychological abuse listed than men (91% and 71% respectively). The difference between men and women was particularly marked for:

- Being repeatedly put down so they felt worthless (58% of women compared with 19% of men);
- Having a partner threatening to hurt them (43% of women compared with 14% of men);
- Having a partner stopping them having their fair share of household money or taking money from them (26% of women compared with six per cent of men);
- Having a partner threatening to kill them (17% of women reported this compared with five per cent of men).

As well as being more likely to experience psychological abuse than men, women experiencing any form of partner abuse since the age of 16 were also more likely to have experienced more of the forms of psychological abuse. On average women had experienced over three forms while men had experienced between one and two of the forms of psychological abuse.

3.4 Form of abuse experienced – physical abuse

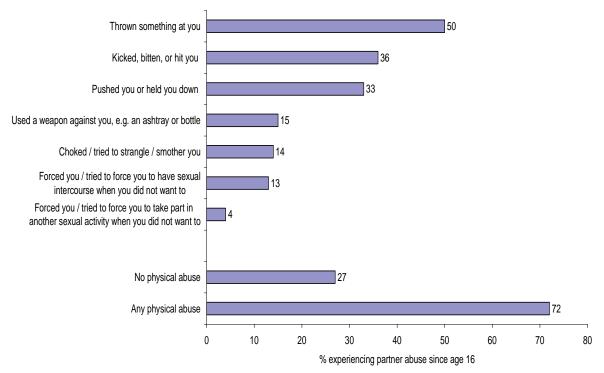
As discussed in section 2.4 above, 13% of adults who had a partner since age 16 had experienced physical abuse (including sexual and other physical abuse) from a partner since that age. This section looks at these instances of physical abuse by a partner since the age of 16 in more detail.

More than seven in ten (72%) of those experiencing any form of partner abuse since the age of 16, experienced physical abuse (Figure 3.2). On average those experiencing physical abuse since the age of 16 mentioned between one and two forms of abuse, fewer than the average number of different types of psychological abuse experienced (section 3.3).

- Half (50%) of those experiencing any form of partner abuse since the age of 16 said they had something thrown at them and 15% said a weapon was used against them;
- Around a third were kicked, bitten or hit (36%) or pushed or held down (33%) and 14% were choked or strangled;
- Forcing or attempting to force them to have sexual intercourse or other unwanted sexual activity were also experienced (13% and four per cent respectively).

Among those experiencing any form of partner abuse, the proportion of men and women experiencing any physical abuse was similar (73% females; 71% males).

Of adults experiencing partner abuse since age 16, women were more likely to have experienced:

- Being pushed or held down (47% of women compared with 11% of men);
- Being kicked, bitten or hit (40% of women compared with 29% of men);
- Being choked / strangled / smothered (21% of women compared with three per cent of men);
- Forced / attempted to force sexual intercourse (20% of women compared with three per cent of men).

In contrast, men experiencing any form of partner abuse were more likely to have experienced having something thrown at them since the age of 16 than women (57% males; 46% females).

3.5 Partner details

The majority (70%) of adults who had experienced at least one form of psychological or physical partner abuse since the age of 16 had just one abusive partner. However, over one in five (22%) had more than one abusive partner since that age.

Around two-thirds (67%) of those who experienced at least one incident of abuse by their partner in the last 12 months were living with them at the time of the most recent / only incident. 43% of these people said they were still living with the perpetrator at the time they were interviewed, that is, the abuse was committed by their current partner.

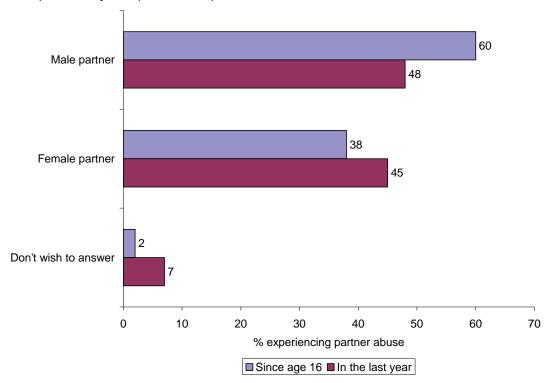
3.5.1 Gender of the offender

In the majority of cases, where partner abuse was experienced since the age of 16, the gender of any abusive partner was male (60%) compared with 38% where the gender of the abusive partner was female. Two per cent did not wish to answer this question.

When considering the gender of the most recent / only abusive partner among those experiencing partner abuse in the last 12 months, 48% were male and 45% female. Seven per cent said they did not wish to answer this question.

For those experiencing partner abuse since the age of 16, the majority of perpetrators were of the opposite gender to them, but for four per cent of men, and one per cent of women, abusive partners were of the same gender.

Similarly, four per cent of men experiencing partner abuse in the last 12 months said their most recent / only abusive partner in the last 12 months was

male and one per cent of women said their most recent / only abusive partner in the last 12 months was female.

3.6 Presence of children

As pointed out in 'Safer lives: Changed lives: A Shared Approach to Tackling Violence against Women in Scotland',¹¹ abuse against a partner can and does have a significant impact on children and young people. This includes where children and young people are directly or indirectly harmed through abuse of the non-abusing parent, usually though not exclusively, the mother.

Examining the presence and involvement of children in partner abuse in more detail:

- One third (33%) of those experiencing partner abuse in the last 12 months, as measured by the SCJS in 2008-09, had dependent children living with them at the time of the most recent / only incident;
- Children were more likely to be living with females than males experiencing partner abuse in the last 12 months (45% and 21% respectively);
- Of those experiencing partner abuse in the last 12 months who had children living with them, in almost two thirds (63%) of cases the children were present at the time the most recent / only abuse occurred;
- Where children were present, the majority (77%) saw or heard what happened, and almost one in five (19%) of those who saw or heard what happened became involved while two per cent were hurt or injured during the incident.¹²

3.7 Impact of incidents

Adults experiencing partner abuse were asked about the effects of the most recent / only incident of abuse they experienced in the last 12 months. Separate questions were asked about psychological and physical impacts. A larger percentage of those experiencing partner abuse mentioned experiencing at least one psychological effect (55%) of the most recent / only incident than mentioned experiencing at least one physical effect (38%). At the same time, a greater proportion said they did not wish to answer in relation to the latter (four per cent and 17% respectively).

Figure 3.4 examines the psychological effects of partner abuse in more detail:

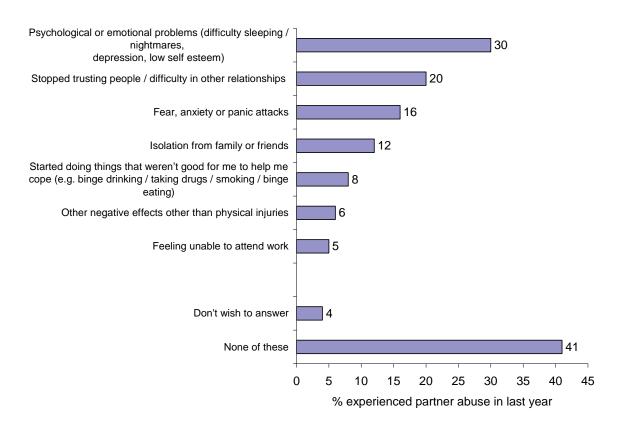

- Psychological or emotional problems such as difficulty sleeping or nightmares, depression or low self esteem were the most frequently mentioned effects of the most recent / only incident of partner abuse, mentioned by three in ten (30%) of those experiencing at least one form of partner abuse in the last 12 months;
- Other psychological outcomes included stopping trusting people / difficulties with other relationships (20%), fear, anxiety and panic attacks (16%) and feelings of isolation from family and friends (12%);
- Over four in ten (41%) of respondents who reported experiencing psychological or physical partner abuse said they had experienced none of the psychological effects listed.

Women were more likely to mention most forms of psychological impacts as a result of partner abuse, particularly:

- More than twice as many women said they suffered psychological or emotional problems such as difficulty sleeping or nightmares, depression or low self esteem (43% compared with 18% men);
- Three times as many women reported fear, anxiety and panic attacks (24% compared with eight per cent of men).

Men (50%) were more likely than women (31%) to say they experienced none of the listed psychological effects. They were also more likely to say they did not wish to answer whether they had suffered psychological impacts.

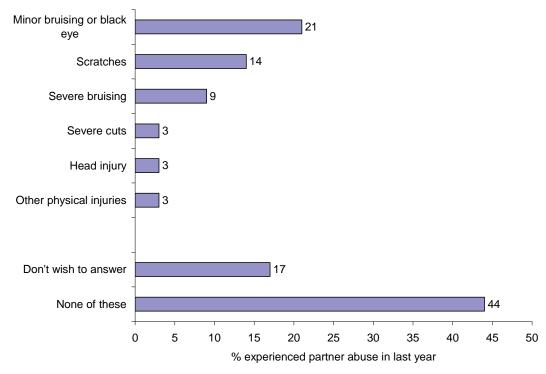
As shown in Figure 3.5, in terms of physical effects of the most recent / only incident of partner abuse experienced:

- Over one in five (21%) suffered minor bruising or a black eye, 14% said they had scratches and nine per cent reported severe bruising;
- More than two in five (44%) said they suffered none of the physical impacts listed and a further 17% said they did not wish to answer.

There were two physical impacts of the most recent / only incident of partner abuse which women were more likely them than men to experience:

- A quarter of women (25%) suffered minor bruising or a black eye compared with 17% of men;
- Almost four times as many women reported severe bruising (14% compared with three per cent of men).

In contrast, scratches were reported as an effect of the most recent / only incident by 18% of males experiencing any form of partner abuse in the last 12 months compared with nine per cent of females.

There were no statistically significant differences between males and females saying they experienced none of the listed physical effects or that they did not wish to answer.

3.8 Perceptions of incidents

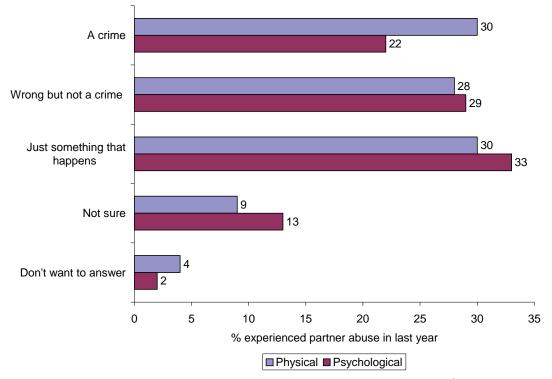
Adults who had experienced any form of partner abuse in the last 12 months as measured by the SCJS 2008-09 were asked whether they considered the abuse they experienced on the most recent / only occasion in the last 12 months to be a crime, wrong but not a crime or just something that happens (Figure 3.6).

- For those experiencing any form of physical abuse in the last 12 months, opinion of the latest / only incident was divided, with 30% saying it was a crime, 28% saying it was wrong but not a crime and 30% saying their experience was just something that happens;
- The pattern was similar for psychological abuse, though slightly fewer (22%) felt the abuse they experienced was a crime. Under three in ten (29%) said it was wrong but not a crime and 33% said it was just something that happens.

Women were more likely than men to view the most recent / only incident experienced as a crime, particularly in relation to physical abuse:

- Over half (54%) of women thought the physical abuse they experienced was a crime compared with nine per cent of men;
- Almost two in five (37%) women said the most recent / only psychological abuse they experienced was a crime compared with six per cent of men.

In contrast, men were more likely to say both forms of abuse were just something that happens:

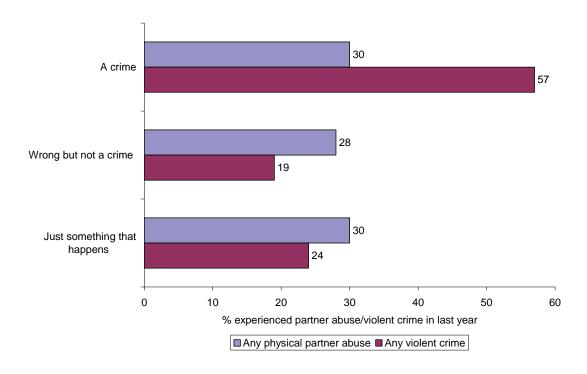
- More than two in five (43%) men said the most recent / only physical abuse they experienced in the last 12 months was just something that happens compared with 14% of women;
- Over half (51%) said the same about the most recent / only psychological abuse they experienced in the last 12 months compared with 18% of women.

Perceptions about the most recent / only incident can be compared with violent crime measured by the SCJS in 2008-09. As this was confined to physical violence, comparisons shown here only include physical partner abuse as measured by SCJS in 2008-09. This comparison showed that:

- The most recent / only experience of physical partner abuse in the last 12 months was much less likely to be described as a crime by those experiencing it (30%) compared with incidents of violent crime as measured by the SCJS in 2008-09 (57%);
- The most recent / only incident of physical partner abuse in the last 12 months was more likely to be described as wrong but not a crime by adults experiencing it (28%) compared with incidents of violent crime (19%) as measured by the SCJS in 2008-09;
- The most recent / only incident of physical partner abuse in the last 12 months was described as just something that happens by 30% of those experiencing it and in 24% of incidents of violent crime as measured by the SCJS in 2008-09.

3.9 Perceptions of being a victim

To set these findings in context, adults who had ever had a partner were asked at the end of the partner abuse section whether they felt that they personally had ever been the victim of domestic abuse.¹⁶

Almost one in ten (nine per cent) agreed, meaning that the self-definition of domestic abuse resulted in a lower proportion of victims being identified than was obtained using the questions detailing specific forms of abuse by a partner (psychological and physical), where, in total, almost one in five (18%) were defined as experiencing partner abuse since the age of 16 (Figure 3.8).

This self-definition of being a victim of domestic abuse was most notably higher among women compared with men (14% and three per cent respectively). As a result, the gap between the self-definition of being a victim of domestic abuse and the SCJS 2008-09 definition of partner abuse was narrower for women than for men:

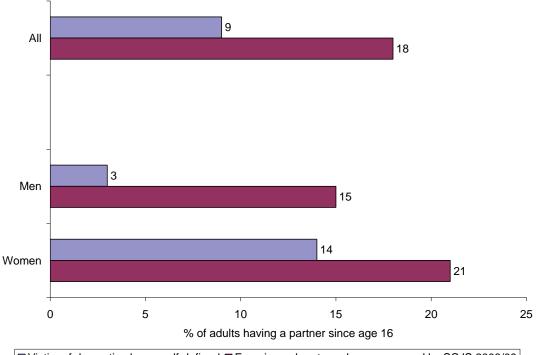
- Women were more likely to say they had experienced any form of partner abuse as defined by the SCJS 2008-09 since the age of 16 (21%) than they were to define themselves as a victim of domestic abuse since that age (14%);
- Men were five times as likely to say they had experienced any of form of partner abuse as defined by the SCJS 2008-09 (15%) than to say they had been a victim of domestic abuse (three per cent).

4 Reporting incidents

4.1 Summary

Almost two-thirds (64%) of those experiencing partner abuse in the last 12 months had told at least one person or organisation about the most recent / only incident they experienced.

• This was most often a friend (37%) or a relative (25%).

Around three in ten (31%) did not tell anyone about the most recent / only incident of partner abuse experienced in the last 12 months.

• This was higher for men (40%) than for women (21%).

In one in five (21%) of the most recent / only incidents of partner abuse experienced in the last 12 months, the police came to know about the incident.

 This was higher for incidents experienced by women (35%) than by men (eight per cent).

Where police came to know about incidents of partner abuse, just over half (53%) of those experiencing it were satisfied with the way the police dealt with the most recent / only incident experienced in the last 12 months and over a third (35%) were dissatisfied.

4.2 Introduction

This chapter looks at reporting of the most recent / only experience of partner abuse in the last 12 months among adults experiencing it as measured in the SCJS 2008-09 including:

- Who the adult experiencing the most recent / only incident told about it:
- Whether the police came to know about the incident and if not, why not:
- Satisfaction with how the police handled the matter.

4.3 Who told about most recent / only incident

Adults who had experienced partner abuse in the last 12 months as measured by the SCJS in 2008-09 were asked who they had told about the most recent / only incident. Two thirds (64%) had told at least one person or organisation about the abuse they experienced in the last 12 months:

 The people they informed were most likely to be someone they knew on a personal level, such as friends or relatives (37% and 25% respectively);

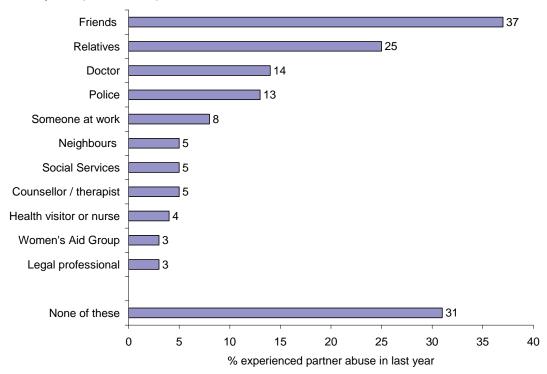
- Fewer said they told the police (13%) or a professional contact, such as a doctor (14%), counsellor / therapist or Social Services (both five per cent);
- Eight per cent said they told someone at work.

Around three in ten (31%) of those experiencing at least one form of partner abuse in the last 12 months did not tell any person or organisation about the most recent / only incident they experienced (Figure 4.1).

Men were significantly more likely not to have told anyone about the abuse they suffered in the last 12 months (40% compared with 21% of women). At the same time, they were also less likely to view what happened to them as a crime or to see themselves as a victim of domestic abuse than were women, which may have influenced their decision (sections 3.8, 3.9)

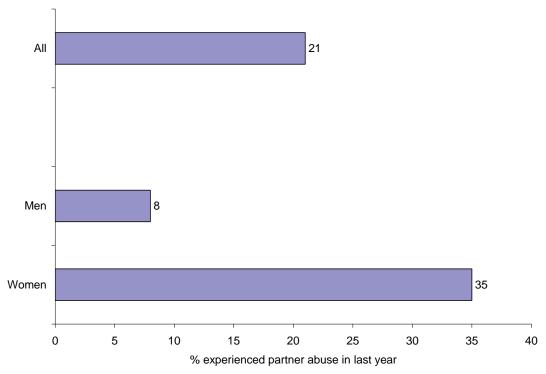
4.4 Reporting to the police

As well as asking about who was told about the incident, a separate question was asked specifically about whether the police came to know about the most recent / only incident of partner abuse experienced in the last 12 months. Around one in five (21%) who experienced partner abuse in the last 12 months said the police did come to know about the most recent / only incident. Again, this figure was significantly higher among women (35% compared with eight per cent of men) (Figure 4.2).

To set this result in context, the police came to know about 20% of the most recent / only incidents of stalking experienced in the last 12 months as measured in the SCJS 2008-09, and 43% of incidents of violent crime as measured in the SCJS 2008-09. 18

4.5 Reasons for not informing the police

As Figure 4.3 shows, in cases where the police did not come to know about the most recent / only incident of partner abuse experienced:

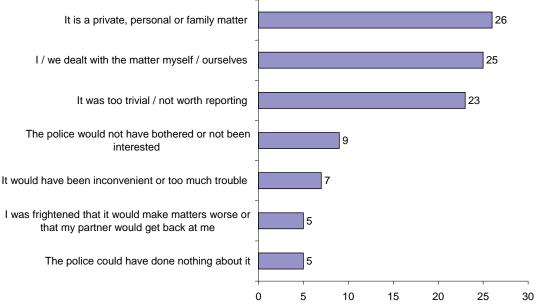

- 26% said it was a private, personal or family matter;
- 25% said they did not report it because they dealt with the matter themselves;
- 23% felt it was too trivial / not worth reporting;
- Fewer than one in ten mentioned a range of other reasons including the police not being interested (nine per cent), it being too much trouble (seven per cent), being frightened of making matters worse and because the police could have done nothing about it (both five per cent).

4.6 Level of satisfaction with police

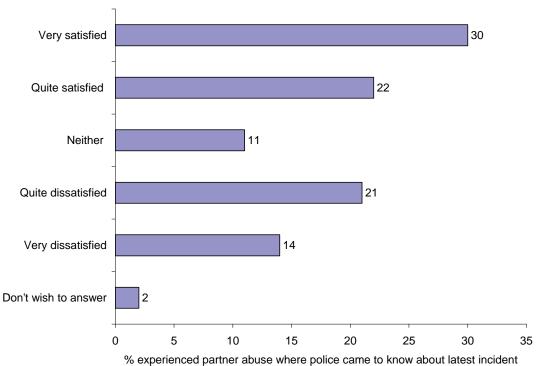
On balance, where the police came to know about the most recent / only incident of partner abuse happening in the last 12 months, those experiencing it were positive about how the matter was handled; just over half were satisfied (53%) including 30%, who were very satisfied, while over a third

All other reasons were mentioned in fewer than five per cent of incidents and are not shown in Figure 4.3.

(35%) expressed dissatisfaction, including 14% who were very dissatisfied (Figure 4.4).

Those experiencing partner abuse in the last 12 months where the police came to know about the most recent / only incident who expressed dissatisfaction with the police handling of the matter were asked why this was. Reasons given included that the police did not take the incident seriously; they dismissed it as a domestic matter; the investigation was not thorough enough and the adult was made to feel in some way responsible for the abuse. The low base size of those expressing dissatisfaction prevents further detailed analysis.²⁰

Annex 2: Self-completion questionnaire method

Crime and victimisation surveys have been carried out in Scotland since the early 1980s. The geographical coverage, sample size, method and reference period have varied across these surveys. The current survey was launched in April 2008 as the Scottish Crime and Justice Survey (SCJS) and it represented a major shift in design, methodology and sample size from previous surveys. The two main changes introduced in the SCJS were an increase in the sample size and a move to continuous fieldwork with a different reference period from that used in previous sweeps.²¹

The target sample size for the SCJS was substantially increased (to 16,000 from around 5,000 in most of the previous crime surveys). The move to a larger sample size was associated with continuous data collection and a change in the survey reference period. The SCJS reference period asked respondents about events that had taken place in the last full 12 months before the date of interview rather than the fixed reference period used previously.

The SCJS 2008-09 self-completion section of the questionnaire covered sensitive subject areas including illicit drug use, partner abuse and sexual victimisation (section A2.4). This improved coverage of these types of crime and ensured that information was collected in an ethical manner. Coverage in the self-completion section in the SCJS in 2008-09 was extended to all adults so that the experiences of older adults were included for the first time.²²

This section provides more detail about aspects of the self-completion section questionnaire and specifically about the questions covering partner abuse. Details are also included about the self-completion interview and the weighting used on the data. Some issues with the data in this section of the self-completion questionnaire are also highlighted.

Further information about the design of the SCJS is contained in annex 2 of 2008/09 Scottish Crime and Justice Survey: First Findings and in the accompanying technical report to the main survey and, of most relevance here, in the accompanying technical note to the self-completion sections. ²³

A2.1 The self-completion interview

Interviews in the SCJS 2008-09 were conducted in the respondent's home using Computer Assisted Personal Interviewing (CAPI) and, for more sensitive questions in the self-completion section of the questionnaire such as those reported here, Computer Assisted Self-completion Interviewing (CASI). Interviews lasted 39 minutes on average in total, with the self-completion section taking just over 8 minutes on average to complete.

The results included in this report are based on interviews conducted by TNS-BMRB between 01 April 2008 and 31 March 2009. Respondents to the SCJS had the option of refusing to participate in the self-completion section which means this part of the questionnaire was not completed by all 16,003 respondents to the main survey. In the SCJS 2008-09, 10,974 respondents agreed to participate in the self-completion questionnaire, a response rate of 69%.

The majority of respondents who answered the questions (66%) used the touch sensitive tablet PC on their own without any help from the interviewer. A third of respondents (33%) asked the interviewer to enter their answers for them, and 14% of respondents entered their own answers but asked the interviewer for some degree of help.

A2.2 Non-response to the self-completion section

Table A2.1 below compares the profile of respondents to the SCJS 2008-09 who answered the self-completion section of the questionnaire (including those who did so with help) and those who did not answer it. It shows that:

- Equal proportions of males and females answered the self-completion section (69%);
- The proportions answering the self-completion section decreased as age increased (for example 76% of 16-24 year olds answered the self-completion section compared with 61% of those aged 60 or over;
- Among women, within age, the proportion answering the selfcompletion section was particularly low among those aged 60 or older (41%);
- A higher proportion of victims of crime as identified in the main survey answered the self-completion section than average while the proportion of non-victims was closer to the average (75% of victims and 67% of non-victims compared with 69% for all respondents to the self-completion section);
- A lower proportion of those living in the 15% most deprived areas answered the self-completion section than average and a higher proportion of those living in the rest of Scotland answered it (58% and 71% respectively).

Measuring partner abuse

The SCJS 2008-09 measured the number of crimes and the proportion of a population who were victims of a crime.

Partner abuse was included in the overall crime measures in the SCJS 2008-09 only if a respondent reported an incident in the screening questions for the victim form that was subsequently coded as a valid SCJS crime.²⁴ There was no screening question that asked specifically about incidents of partner abuse, though a question asking about any form of *violence from a household member* was included. Where possible, the details of partner abuse collected through the victim form were incorporated into the self-completion data and are included in this report.

Previous crime surveys have identified that incidents of partner abuse are under-reported through the interviewer administered questionnaire. In the SCJS 2008-09, the partner abuse section in the self-completion section was extended with a view to providing more detailed information about the extent and nature of domestic abuse in Scotland (section A2.6). In doing this, priority in decision-making was given to ethical considerations about the questions asked.

A2.3 Questionnaire development

During the original questionnaire development phase of the SCJS 08-09, a set of questions in the self-completion section of the questionnaire was specifically developed to elicit people's experience of partner abuse. Ethical considerations were paramount in the development of these partner abuse questions and related decisions.

The motivation both to collect information as sensitively as possible and to reduce the burden placed on respondents influenced the decision to use self-completion data collection. The partner abuse questions did not to ask about each incident occurring within the reference period separately and they did not fully replicate or repeat the questions in the victim form. As a result, the number of questions asked about an incident was greatly reduced.

The draft self-completion questionnaire sections covering partner abuse (reported here) and sexual victimisation (reported separately)²⁵ were discussed with representatives of three organisations concerned with the domestic abuse and sexual victimisation of males and females. A summary report of the discussions and the changes made to the questions as a result is available on the SCJS website.²⁶

A2.4 Questionnaire content

The SCJS 2008-09 questionnaire ²⁷ consisted of three elements:

- The main questionnaire, which includes screener questions on incidents that may have happened to the respondent or their household and which filters respondents into or out of the victim form;
- A repeated victim form which collected details about the separate incidents a respondent may have experienced;

 A self-completion questionnaire covering sensitive issues including drug use; partner abuse and sexual victimisation.

The questions on partner abuse were included in the self-completion section of the SCJS 2008-09 questionnaire. Respondents were first asked whether they had a partner since the age of 16 and in the last 12 months, or had contact with an ex-partner in the last 12 months. Those who had a partner were also asked if had lived with a partner since the age of 16 and in the last 12 months. Those who had at least one partner since the age of 16 were shown lists of a range of psychological and physical forms of abuse and asked if a partner or ex-partner had done any of those things to them. If so they were asked when these things had happened and the gender of the perpetrator(s). Where they had experienced more than one form of abuse since the age of 16 they were asked how many different partners had done this.

Where abuse had happened in the last 12 months, more questions were asked about the most recent / only incident. These included a series of questions about whether children were affected by the abuse. Other questions included the gender of the perpetrator; the physical and psychological consequences of the abuse; whether the adult experiencing partner abuse informed other people or organisations about the incident and specifically whether the police came to know about it. Information was gathered on whether the person experiencing the partner abuse was living with the perpetrator at the time of the incident and whether they were living with them at the time of the interview.

Respondents' opinions of the abuse were gathered. First, those who said they had experienced at least one of the psychological or physical abuses listed in the questionnaire were asked whether they thought the most recent / only abuse was a crime, wrong but not a crime or just something that happens. Subsequently all respondents, regardless of whether they had experienced any of the listed abuses, were asked whether they thought they had ever been the victim of domestic abuse.

To avoid repetition, the self-completion section of the questionnaire was linked to the victim form. This meant that questions relating to incidents which had been recorded previously in the victim form were not repeated there. Instead data provided in the victim form was subsequently incorporated into the data included in this report.

A2.5 Disclosure of sensitive information

Given the sensitive nature of the questions, a separate don't wish to answer button was provided at the top of the screen at every question in the self-completion section of the questionnaire. At the start of the questions on partner abuse, respondents were reminded that they could skip such sensitive questions that they did not want to answer:

The questions may seem personal but it is very important in helping us understand more about these types of crime,

which can affect both men and women. If the questions upset you in any way you can just pass over them by pressing 'Don't wish to answer'. However, we hope you will continue to the end.

For the two initial screening questions which established whether a respondent had experienced psychological or physical abuse, one per cent said they did not wish to answer either question. Of those who said they had experienced either form of abuse, most people went on to answer the follow-up questions although for most of the questions, a small number of respondents did use the don't wish to answer button.

A2.6 Changes between the SCJS 2008-09 and the SCVS 2005-06

There were a number of changes made to the SCJS 2008-09 from the SCVS 2005-06 in relation to partner abuse. This means that trends cannot be identified by comparing the two surveys.

Importantly, the definition of partner abuse was broadened to in the SCJS in 2008-09 to include psychological abuse (including emotional, financial and other psychological abuse) and physical abuse (including sexual and other physical abuse). A single question was used in the SCVS 2005-06 to identify adults experiencing partner abuse:

QDV2: In the period since 1 April 2005 did your partner or your ex-partner ever do either of the following?

YOU CAN CHOOSE MORE THAN ONE ANSWER AT THIS QUESTION IF YOU WISH

- 1. Say frightening things to you (such as threatening to harm you or someone close to you, such as your children)
- 2. Use force towards you (this could include grabbing, pushing, shaking, hitting, kicking etc)
- 3. No
- 4. Don't want to answer

In the SCJS 2008-09 two questions were used to identify adults experiencing psychological and physical forms of partner abuse respectively:

DA1i: Since you were 16, has any partner or ex-partner ever done any of the following things to you? By partner, we mean any boyfriend or girlfriend, as well as a husband, wife or civil partner.

YOU CAN CHOOSE MORE THAN ONE ANSWER AT THIS QUESTION IF YOU WISH

- 1 Stopped you having your fair share of the household money or taken money from you
- 2 Stopped you from seeing friends and relatives
- 3 Repeatedly put you down so that you felt worthless
- 4 Behaved in a jealous or controlling way e.g. restricting what you can do, who you can see, what you wear
- 5 Forced you to view material which you considered to be pornography
- Threatened to kill or attempt to kill themselves as a way of making you do something or stopping you from doing something
- 7 Threatened to, attempted to or actually hurt themselves as a way of making you do something or stopping you from doing something
- 8 Threatened you with a weapon, for example an ashtray or a bottle
- 9 Threatened to hurt you
- 10 Threatened to hurt someone close to you, such as your children, family members, friends or pets
- 11 Threatened to hurt your other / previous partner
- 12 Threatened to kill you
- 13 None of these
- 14 Don't know / can't remember
- 15 Don't wish to answer

DA1iii: Since you were 16, has any partner or ex-partner ever done any of the following things to you? By partner, we mean any boyfriend or girlfriend, as well as a husband, wife or civil partner.

YOU CAN CHOOSE MORE THAN ONE ANSWER AT THIS QUESTION IF YOU WISH

- 1 Pushed you or held you down
- 2 Kicked, bitten, or hit you
- 3 Thrown something at you
- 4 Choked or tried to strangle / smother you
- 5 Used a weapon against you, for example an ashtray or a bottle
- 6 Forced you or tried to force you to have sexual intercourse when you did not want to
- Forced you or tried to force you to take part in another sexual activity when you did not want to
- 8 None of these
- 9 Don't know / can't remember
- 10 Don't wish to answer

Another difference that makes it not possible to identify trends between the two surveys is the length of the reference period used for more recent experiences. In the SCVS 2005-06 the fixed reference period ran from 1st April 2005 to the interview date (between June and December 2006). Consequently, rates were reported on recall periods of varying length that ranged from 14 to 20 months. In the SCJS 2008-09 the rolling reference period was 12 months for every respondent, regardless of when the interview took place.²⁸

Although trends cannot be identified, it is interesting to note from a methodological point of view that the approach used in the SCJS 2008-09 generated higher estimates of psychological or physical abuse since the age of 16 than the previous survey. Almost two in ten (18%) adults had experienced partner abuse as measured in the SCJS 2008-09 since the age of 16 compared with around one in ten (10.5%) measured in the SCVS 2005-06. It is highly likely that differences in the questions used were responsible for this difference in estimates. More extensive lists of different forms of psychological or physical abuse were used to generate the estimates in the latest survey compared with the previous one. The other changes discussed above made between the two surveys may also have contributed to this difference.

A2.7 Data issues

As highlighted in section 2.3, partner abuse as defined by the SCJS 2008-09 could only occur where a partner was present in someone's life. As a result questions were asked about whether the respondent had a partner since the age of 16 and had a partner or contact with an ex-partner in the last 12 months (RELO; RELOi). Subsequent analysis was based on those having a partner since the age of 16 when reporting partner abuse since that age, and those having a partner or contact with an ex-partner in the 12 months prior to interview when reporting partner abuse in the last 12 months.

The first data issue related to these questions. In the questionnaire, it was possible for respondents to say they had experienced at least one of the forms of either psychological or physical abuse by a partner in the last 12 months, while saying that they had not had a partner or contact with an expartner in the last 12 months.²⁹ 68 respondents had done this.

These cases have been included in the analysis as if they had said they had a partner or contact with an ex-partner in the last 12 months. This is because they had provided answers to the follow-up questions giving more detail about the most recent / only incident of partner abuse and these were given precedence over the answer to the question on whether they had a partner or not.

For simplicity, the base text for figures including those 68 respondents showing the percentage experiencing partner abuse in the last 12 months is referred to as 'all who have had partner or been in contact with an ex-partner in the last 12 months'. Accompanying text is treated in the same way.

Changes made after the extensive piloting for the SCJS 2008-09 led to two other data errors on two questions. The questions involved were DA9 and DA1iii.

DA9 asked those experiencing at least one form of partner abuse about the psychological impacts of the most / recent only incident of partner abuse they had experienced. Those saying they had previously provided details of the partner abuse in the victim form were not asked all of the questions in the partner abuse section. Instead the data they had previously provided was forced into partner abuse data to avoid repetition and reduce the burden on respondents.

The question about psychological impacts included options more tailored to domestic abuse, rather than a more general question on emotions that included options that could apply to any type of crime which was asked in the victim form. This meant that answers could not be forced from the victim form question. However, those who provided information about incidents of partner abuse in the victim form were not asked the psychological impacts question in

the self-completion section of the questionnaire in error as it appeared among other questions that were skipped. As a result the number answering this question was reduced by 72 (Figure 3.4).

The final data issue relating to partner abuse in the SCJS 2008-09 involved the question DA1iii which asked the types of physical abuse experienced. It involved subsequent routing from this question between April and November 2008, after which the routing error was corrected.

Two codes were added to the final questionnaire after piloting was completed. These were:

- Forced you or tried to force you to have sexual intercourse when you did not want to;
- Forced you or tried to force you to take part in another sexual activity when you did not want to.

The data for two questions were affected if a respondent had experienced no other forms of physical abuse apart from these two. The data was affected for 13 questions (plus follow-ups), if the respondent had not experienced any other form of physical abuse and had not experienced any form of psychological abuse.

In detail, the 43 people who only experienced at least one of these two forms of physical partner abuse and not any other forms of physical abuse since the age of 16 were not asked when this had happened (DA1iv) or whether they thought the most recent or only physical abuse experienced in the last year was a crime or not (DA18).

The remaining questions in the partner abuse section were asked once about any physical or psychological abuse combined. The 18 people who only experienced at least one of these forms of physical partner abuse and did not say they had experienced any form of psychological partner abuse were excluded from the follow-up questions in that section of the self-completion questionnaire (DA1v to DA17; DA19).

A copy of the questionnaire, providing details of the questions highlighted above is included in the technical report annexes that accompany the SCJS 2008-09.³⁰

A2.8 Weighting

The results obtained in the SCJS 2008-09 were weighted to correct for the unequal probability of selection for interview caused by the sample design and for differences in the level of response among groups of individuals.

In view of the reduced response to the self-completion section, some additional weighting was necessary for use when analysing this sub-sample. The self-completion weights were calculated in a similar way to the main individual and household weights but based only on respondents who had answered the self-completion section of the questionnaire.³¹ The individual weight was applied to all of the questions included in this report as they all related to the experiences and opinions of individuals.³²
