STAFF OF SCOTTISH LOCAL AUTHORITY SOCIAL WORK SERVICES, 2010



29 June 2011

This publication contains statistics obtained from the staffing census held across all local authorities on 4 October 2010. It presents findings from a range of statistics to provide an overall picture on staffing levels, and details about the staff in filled posts.

Information on vacancies is also provided. However, care must be taken when looking at these due to difficulties local authorities have in reporting this information, and inconsistencies in how vacancies are being reported by local authorities. As a result, comparisons across local authorities is not appropriate.

The main findings are:

- There were 41,062 whole time equivalent (WTE) staff employed by Scottish local authority social work services departments in October 2010, which corresponded to 7.9 staff per 1,000 population. (Table 1)
- However, this total WTE staff figure includes 323 WTE staff (largely teachers and assistants who work with children with additional support needs) who are now being included in this Census by Scottish Borders as a result of its new integrated Children's Services. Excluding these additional staff, the total number of WTE staff employed would have been 40,739, a fall of 2.3% compared with the comparable figure the previous year. (Table 1)
- In October 2010, there were 5,201 WTE qualified social workers, a fall of 0.6% compared with October 2009. (Table 2)
- The average (median) age for staff in filled posts in October 2010 was 47 years old. This was the same as in October 2009, but higher than the average (median) age of 45 years old in October 2004. The average (median) age was highest for Senior Mangers, etc. (50 years old) and lowest for Trainee Social Workers (39 years old). (Table 3)

- It is estimated that 5.7% of all posts were vacant as at October 2010, compared to 7.0% in October 2009. This is based on the 27 out of 32 local authorities who provided vacancy information (Table 4).
- Only 28% of all reported vacancies were known to be in the process of being filled at the time of Census (nb. for 29% of all vacancies reported, information as to whether the vacant post was in the process of being filled or not was not provided).
- It is estimated that 4.8% of all social worker posts were vacant as at October 2010, compared with 6.8% in October 2009. (Table 4).
- Only 47% of all reported social worker vacancies were known to be in the process of being filled at the time of Census (nb. for 25% of all social worker vacancies reported, information as to whether the vacant social worker post was in the process of being filled or not was not provided).

Table 1 shows the number of whole time equivalent (WTE) staff and staff per 1,000 population in local authority social work services departments, by local authority for the years 2006 to 2010.

There were 41,062 whole time equivalent (WTE) staff employed by Scottish local authority social work services departments in October 2010. However, this total WTE staff figure includes 323 WTE staff (largely teachers and assistants who work with children with additional support needs) who are now being included in this Census by Scottish Borders as a result of its new integrated Children's Services. Excluding these additional staff, the total number of WTE staff employed would have been 40,739, a fall of 2.3% compared with the comparable figure the previous year.

The 41,062 WTE staff in October 2010 corresponded to 7.9 staff per 1,000 population. The level of staffing in each council is influenced to some extent by the level of social work involvement required, which in turn, may be affected by a range of factors, including deprivation and urban/rural issues. Other factors affecting the level of staffing include the extent to which services are contracted out and the extent to which services are provided in partnership with neighbouring local authorities and other organisations. The number of staff per 1,000 population was highest in the island councils (31.5 in Shetland Islands, 21.9 in Orkney Islands and 18.2 in Eilean Siar), and lowest in Dumfries & Galloway (4.8).

Table 2 shows the number of whole time equivalent (WTE) social workers in local authority social work services departments, by local authority for the years 2001 to 2010.

In October 2010, there were 5,201 WTE qualified social workers, a fall of 0.6% compared with October 2009.

East Ayrshire had the largest percentage fall in social workers between 2009 and 2010, from 127 WTE in 2009 to 99 WTE in 2010 (a fall of 22.4%), whilst Stirling had the second largest percentage fall, from 93 WTE in 2009 to 79 WTE in 2010 (a fall of 15.1%).

East Dunbartonshire had the largest percentage increase in social workers between 2009 and 2010, from 43 WTE in 2009 to 49 WTE in 2010 (an increase of 13.6%), whilst Clackmannanshire had the second largest percentage increase, from 38 WTE in 2009 to 42 WTE in 2010 (an increase of 12.2%).

Table 3 shows the average (median) age of staff in local authority social work services departments, for the years 2004, 2009 and 2010.

The average (median) age for staff in filled posts in October 2010 was 47 years old. This was the same as in October 2009, but higher than the average (median) age of 45 years old in October 2004. The average (median) age was highest for Senior Mangers, etc. (50 years old) and lowest for Trainee Social Workers (39 years old).

Table 4 shows the percentage of WTE social work services posts that were vacant in 2009 and 2010, by staff group. Due to the different employment conditions which apply for home care staff in many local authorities, all the vacancy tables show vacancy rates excluding home care staff.

In order to produce an estimate for the percentage of vacant posts in Scottish Local Authority Social Work Services in 2009 and 2010, only the information from the local authorities who provided vacancy information within each respective year has been used. This was a change to how this had been done previously because it has now been a number of years since the City of Edinburgh has been able to provide information on vacancies. Therefore, it was felt no longer appropriate to simply carry forward such out-of-date figures. As a result of this change in methodology, the previously published October 2009 vacancy rates were recalculated using the same methodology. This resulted in the overall vacancy rate being revised from 7.1% (as published in June 2010) to 7.0%.

It is estimated that 5.7% of all posts were vacant as at October 2010, compared to 7.0% in October 2009. However, vacancy rates were highest for trainee social worker posts (7.4% of these posts were vacant) and lowest for other domiciliary staff (3.1% of these posts were vacant).

From looking at the overall drop in the number of filled posts, and the overall fall in the estimated percentage of posts reported as being vacant, then readers should note that this has occurred because the total number of posts in local authority social work services departments has fallen. This could be due to a number of factors such as reorganisation, budget constraints, etc..

Therefore, these factors must be taken into consideration when looking a current vacancy rate levels and/or comparing vacancy rates over time.

 (13) For this publication, the overall vacancy rate for Scotland has been estimated based only on those local authorities who were able to provide vacancy information. In order to enable a comparison with the previous year, the 2009 figure has been re-calculated on the same basis. This re-calculation revised the overall vacancy rate from 7.1 percent to 7.0 percent, but has resulted in larger changes by staff group. Therefore, figures published for years prior to 2009 are not directly comparable with these figures

BACKGROUND NOTES - Staff of Scottish Social Work Services

1. Notes and Definitions

Method of Collection

- 1.1 Each local authority is asked to submit an annual census form detailing the staff employed by its social work/social services department, whether free-standing or part of a larger department. The census date is the first Monday in October.
- 1.2 Details such as post category, whole-time equivalent, gender of staff, age of staff, ethnicity and disability of staff, contract type, registration requirements, and number of vacancies are collected.

Organisation of Social Work Services

1.3 Social work services can be organised in a number of different ways, and this may impact on the results reported in this publication.

Estimates and Revisions

- 1.4 October 2010 vacancy data was not provided by East Dunbartonshire, City of Edinburgh, Eilean Siar, Inverclyde and West Dunbartonshire. In order to produce an estimate for the percentage of vacant posts in Scottish Local Authority Social Work Services, only the information from the 27 local authorities who provided vacancy information has been used. This was a change to how this had been done previously because it has now been a number of years since the City of Edinburgh has been able to provide information on vacancies. Therefore, it was felt that it was no longer appropriate to simply carry forward such out-of-date figures. As a result of this change in methodology, the October 2009 vacancy rates were re-calculated using the same methodology. This resulted in the overall vacancy rate being revised from 7.1% (as published in June 2010) to 7.0%. However, the size of the revisions is greater when looking at overall vacancy rates by staff group, client group and activity/location.
- 1.5 Because of the way they now operate, it is becoming increasingly difficult for some local authorities to provide vacancy information as they are no longer recorded or managed centrally. As a result, the Scottish Government attempted to develop this statistical return for this October 2010 Census with the aim of also collecting the number of vacancies currently in the process of being filled as at the 'snapshot' Census date. This should have meant that all local authorities will be able to supply some form of vacancy information. However, this has not been the case. Therefore, vacancy information has been based on the information as reported by local authorities.

1.6 Major changes to both staffing and vacancy figures took place in October 2006. These included:

The introduction of an employee status variable which was established to highlight those staff actually working in posts on the census date (including those covering an absentee) and those who were absent (e.g. on maternity leave). This was introduced to eliminate double-counting of staff which was brought to our attention during discussions with local authorities. As a result any changes in the numbers and WTE of staff between 2006 and previous years will then be affected as a result of eliminating this double counting.

- 1.7 Information on starters and leavers in local authority social work services was requested for the fourth time in October 2010. Similar to last year, a number of local authorities were unable to provide this information. Due to the fact there was only limited data available, no analysis of starters and leavers has been included in this publication. However, some analysis of the information provided will be made available on request or added to the additional tables published alongside this publication. However, although this would provide users with some information as to the entry source to, as well as the leaving destination and reason for leaving, local authority social work services, this information would need to be treated with some caution.
- 1.8 Also, staff flows information could be affected by any reorganisation and restructuring of local authority social work services departments, as staff could be re-assigned to different posts, etc..

Changes Over Time

- 1.9 As a result of changes in the classifications used on census forms, breakdowns into different activities, locations or staff groups are not always strictly comparable across years.
- 1.10 It should also be noted that different local authorities may classify staff differently, according to the way work is organised in their area. Social workers, for example, may be classified either under generic provision, or by the nature or location of their work (adult services, children's services etc.).

Number of Staff

1.11 The number of staff is a count of filled posts. Therefore, if a member of staff is filling more than one post (e.g. a full-time employee is filling two or more posts by working on a part-time basis in each post), then the person will be counted more than once (and as a part-time person in each post). Therefore, this is not an actual count of physical staff employed within local authorities.

Whole Time Equivalent (WTE)

- 1.12 Whole Time Equivalent (WTE), where used, is an addition of i) the number of full-time staff, and ii) the total number of hours worked by all the part-time staff in a week, divided by the number of hours considered to be the standard full-time week for a member of staff in each category. It should be borne in mind that WTE figures may be calculated using different weekly hours in different categories and also between local authorities. This can have the effect of WTE figures being slightly higher in local authorities who have reduced their standard full-time working week, but the number of part-time hours worked remains the same.
- 1.13 WTE figures have been rounded independently. As a result, WTE totals in tables may not equal the sum of the categories shown.

1.14 The following terms are used in the tables:

2. Future Availability of Social Care and Social Work Services Workforce Information

- 2.1 Since Summer 2010, the Scottish Government's Education Analytical Services Division have been actively reviewing the statistical collections it conducts. As part of this review, the future demand for, and determining which organisation should be the source of workforce information for the entire social care and social work services workforce was taken in to consideration.
- 2.2 Currently, information for a large proportion of this sector's workforce is covered by two separate sources: this Local Authority Social Work Services Staffing Census, and the Social Care and Social Work Improvement Scotland's (SCSWIS) (formerly the Care Commission) Annual Returns.
- 2.3 However, Section 58 of the Regulation of Care (Scotland) Act 2001, states that Scottish Ministers shall have the functions of ascertaining what numbers of social workers and social service workers of other descriptions are required within Scotland, and that any function of the Scottish Ministers under this section of the Act may be delegated by them to the Scottish Social Services Council (SSSC).
- 2.4 Therefore, as part of this statistical review, the Scottish Government has been actively working with the SSSC with the aim of the function outlined in Section 58 of the Act being formerly delegated to them. As part of this function, the SSSC have agreed to take over responsibility for the gathering of local authority social work services workforce information that would not be captured in SCSWIS Annual Returns (mainly Local Authority Strategic/Central Staff and Fieldwork Staff), starting with the 2011 Census.
- 2.5 As part of its Annual Returns, SCSWIS will continue to gather detailed workforce information for other parts of this sector's workforce, including staff employed in local authority Day Centres and Residential Establishments, as well as staff working in social care and social work services provided by private and voluntary organisations. Appropriate and relevant data sharing agreements have been put in place in order for this workforce information to be shared with the SSSC in order for them to carry out its delegated function on behalf of Scottish Ministers.
- 2.6 The culmination of this exercise is that the SSSC will, in future, be the source of workforce information for the entire social care and social work services workforce, and will produce and publish statistical workforce reports that covers the entire sector (i.e. public, private and voluntary), not just local authority employed staff. Therefore, future workforce reports will provide a much more comprehensive picture of the workforce for the entire sector.
- 2.7 The SSSC have already started this by publishing a Scottish Social Services Workforce Data Report 2008 in November 2010, and an equivalent 2009 report on 9 June 2011, which can be found here. The current plans are that the SSSC will publish a similar workforce report based on 2010 data by December 2011. From September 2012, the SSSC will then produce updated Workforce reports on an annual basis using the latest available information.
