### **Minister's Foreword**

PROTECTING CHILDREN TODAY AND TOMORROW - a multi disciplinary review of child protection measures across Scotland



This review is part of the government's response to the recommendations of the Hammond report following the tragic death of a 3-year-old child, Kennedy McFarlane. I am determined that we will do our best to prevent a repeat of this kind of incident.

No child should ever fall through the protection net just because professionals failed to work together.

Although a lot has been done to improve child protection in recent years we must do all we can to ensure our systems do not fail those vulnerable children who rely on them.

That is why the review has brought together health, education, police, children's reporters and social work in a team that will carry out an audit and review of child protection arrangements across Scotland; providing a report to ministers in the summer of 2002.



#### 20 March 2001 : Mcconnell Announces Review To Improve Child Protection Arrangements

Minister for Education, Europe and External Affairs, Jack McConnell today announced a review to improve child protection arrangements in Scotland.

Speaking at a conference on better integrated children's' services, Mr McConnell said:

"Dumfries and Galloway's Child protection Committee commissioned a report following the recent tragic case in their area..

"One of their recommendations was that there should be a multidisciplinary review of child protection and today I can announce that we have decided to do just that.

"Our Social Work Services Inspectorate and Health department will be central to this review with support from the school and police inspectorates.

"Although a lot has been done to improve child protection in recent years, we must do all we can to ensure our systems do not fail those vulnerable children that rely on them.

"I am determined that we will do our best to prevent a repeat of this kind of incident. It is vital that we do more than just talk about joined up working. We must ensure that everyone – local government, agencies and departments work better together locally to give the best service possible to our young people. No child should ever fall through the protection net just because professionals fail to work closely together.

"This review is a good example of working together and I am confident it will make a difference to the children who need our support most."

I have responsibility for the Children and Young People's team in the Social Work Services Inspectorate. Previous work includes the reviews of sex offenders 'A Commitment to Protect' and women offenders 'A Safer Way.'

I am a consultant paediatrician, based at the Royal Hospital for Sick Children in Edinburgh, which is part of the Lothian University Hospitals NHS Trust. As the Lead Clinician for Child Protection in the Trust, I am responsible for the service which provides the medical assessment of children in whom there are concerns regarding abuse and neglect, and for ensuring effective interagency working. I am also the current chair of the Scottish branch of BASPCAN (British Association for the Study and Prevention of Child Abuse and Neglect).

#### Jan Ramchurn - Inspector

As the child protection adviser I am responsible for child protection issues in Lothian Primary Care (NHS) Trust. I advise health professionals, mostly nurses and health visitors, when they have child protection concerns. My main interest in child protection work is the early identification of vulnerable children and promoting the concept of interagency intervention to protect such children.

#### **Ian Ross - Inspector**

I am a Detective Chief Inspector of Lothian and Borders Police and have had responsibility for Child Protection issues within the force. I have been involved in the development of a national police training course and a protocol for the investigation of historical abuse.

#### **David Sorensen - Statistician**

I am a statistician working in the Scottish Executive Education Department and my current post covers 3 main areas: children's social work (child protection, children looked after etc), collection of education data from local authorities, and teacher analysis. The work involves management of a number of different surveys, as well as data analysis, modelling, publication and policy briefing.

I am a researcher in the Social Work Services Inspectorate. I previously worked on the Annual Report of Social Work Services and carried out various pieces of work for the National Care Standards Working Groups.

'Child protection' covers a lot of different things. It is important for all of us in Scotland that children feel safe and looked after wherever they are, at home, in school, in clubs and in the community. If children have a happy and safe childhood then they are more likely to grow up to be kind adults and good parents themselves. So, all of us, whether professionals working with children, members of the general public or children, have a part to play in keeping children safe. This can include all sorts of things such as:

- making sure that there are safe places for children to play
- driving safely and slowly in areas where children play
- helping friends and neighbours with babysitting
- speaking out if we suspect a child is suffering
- volunteering at clubs for children
- taking part in community projects
- helping out at a local school
- listening to children and hearing their views about things that affect them.

For most children life is pretty good most of the time. Most parents try very hard to look after their children properly. However, sometimes things can go wrong. Some parents who are unhappy themselves or are feeling very stressed may not be able to give children all their attention and sometimes children can be hurt by their parents. Sometimes other people who have contact with children may try to harm them in some way. It is these kinds of situations that are dealt with by the formal child protection systems in Scotland.

If a child is being abused or neglected in any way then they, their parents, or someone on their behalf, should contact the local social work department or the police. People may also choose to speak to a teacher, doctor, health visitor, Reporter to the Children's Panel or other trusted adult. All of these professionals will work closely together to make sure that they protect the child and offer support

to the parents.
