Operation of the homeless persons legislation in Scotland: 2007-08

INTRODUCTION

- 1. This Statistics publication provides information on applications to local authorities for assistance under the homeless persons legislation covering the period to 31 March 2008. It includes information on the characteristics of applicant households, local authority assessments and the action taken in respect of cases that were concluded. Snapshot data on households in temporary accommodation at 31 March are presented, together with data on the implementation of the Homeless Persons (Unsuitable Accommodation) (Scotland) Order 2004.
- 2. This bulletin provides the first full year's analysis following revision of homelessness data collection which took effect from 1 April 2007. In particular the bulletin provides new analyses on the housing circumstances of homeless applicants in the period immediately before applying for assistance, provides more detail on support needs and on outcomes of applications. This bulletin provides summary tables and charts. More detailed reference tables have also been published on the Scottish Government website at Housing and Regeneration Publications

Main points

3. The main points are:-

Applications and applicant households

- There were an estimated 56,609 applications to local authorities under the Homeless Persons legislation in 2007-08. This represents a decrease of 4.9% compared to the 59,550 applications during 2006-07 (Table 1 and Chart 1).
- The majority of households applying were single-person households (60%), mainly men. Single parents, predominantly women, accounted for the next largest group (24%) (Table 2 and Chart 2).
- The main reasons for applying as homeless were household disputes or relationship breakdown (27%) and being asked to leave their current accommodation (25%) (Table 5 and Chart 11).
- 42% of applicants in 2007-08 had been living with relatives or friends before applying, 35% had been living in accommodation which they either rented or owned, 3% had come from prison and 3% had come from supported accommodation. (Table 3).
- For those who had been living with family or friends the main contributing factors for loss of accommodation were external factors such as the landlord selling the property, harassment or antisocial behaviour by others, flood or fire cited by 27%- and lack of support from family or friends cited by 15%. (Table 4 and Chart 10)
- Of the 4,228 applications for homelessness assistance from owner occupiers, 26% cited financial difficulties/ debt or unemployment as contributing to their loss of accommodation while 22% cited external factors. (Table 4 and Chart 9)
- Just under a third (32%) of those who had been renting cited external factors as a contributing to their loss of accommodation while 15% cited financial difficulties/ debt or unemployment. (Table 4 and Chart 9)
- In 2007-08 some 6% of applicants an average of 282 applicants per month slept rough the night before applying for assistance. The proportion of applicants sleeping rough the night before applying varied from around 15% in Edinburgh and Aberdeen to below 1% in North Lanarkshire, West Lothian, Dundee, South Lanarkshire and Midlothian. (Chart 13).

- 36% of applications were from households on councils' waiting lists. This varied widely between councils from 70% in Aberdeenshire to around 10% in South Ayrshire. (Chart 12)
- The percentage of homeless applications identified as repeat applications (i.e. where a previous application from the household had been closed less than 12 months before the current application¹) has fallen from 9.2% in 2003-04 to 6.7% in 2007-08. (Chart 14)

Local authority assessment

- At the time of this analysis, of the 56,609 applications in 2007-08, 40,299 had been assessed as homeless 14,633 were either not homeless or lost contact and 1,677 had not yet been assessed. (Table 1)
- Of the 40,299 applications assessed as homeless, 32,111 (79.7%) were assessed as priority. (Table 1). This was a 3.0 percentage points increase over 2006-07, which in turn was a 1.2 percentage points increase over 2005-06. (Table 1 and Chart 3).
- The proportion of homeless households assessed as priority in 2007-08 varies widely between councils, from 96% in West Dunbartonshire to under 70% in Moray, Fife, Stirling, Aberdeen City, East Ayrshire, East Lothian and Shetland. (Chart 16)
- By 2007-08 single people aged between 25 and retirement were the largest priority group, their numbers having increased from a little over 5,000 in 2000-01 to over 9,000 in 2007-08. (Chart 15)
- In 2007-08, 34% of households were assessed as having one or more support needs. 12% of homeless applicants required support because of a mental health issue, 11% needed support on skills for independent living and 10% required support because of alcohol dependency. (Chart 17)
- In 2007-08 the most common reasons for a priority assessment were that the household had dependent children (39% of all priority assessments), a household member was vulnerable (16%), the applicant household was fleeing domestic violence or abuse (14%) or mental illness or personality disorder of a household member (12%). (Chart 18)

Action taken by local authorities

- There were 51,476 applications actioned by local authorities during 2007-08. Of these 10,835 were cases in which the application had been withdrawn or contact lost with the applicant before an assessment could be made and a further 7,209 were cases where contact was lost before the council discharged its duty.
- In 2007-08 17,447 households were offered a social rented tenancy of whom 15,598 (89%) took up the offer. Temporary accommodation was offered to 4,289 households of whom 59% took up the offer and a private rented tenancy was offered to 1,573 households of whom 99% took up the offer. (Chart 19)
- The most common actions taken by councils to try to prevent homelessness in the 6,383 households who were either threatened with homelessness² or were assessed as not homeless in the period were:-
 - assistance in finding alternative accommodation, provided to 28% of this group of households;
 - assessment of support needs, provided to 23% of this group;
 - independent financial, legal or housing advice, provided to 16%;
 - basic housing support to manage finances or living alone, provided to 12%;
 - assistance in dealing with landlord or mortgage provider, provided to 9%;
 - assistance in claiming benefits, provided to 8%
 - use of a rent deposit/ guarantee scheme, provided to 6%
 - services such as counselling, mediation and befriending, provided to 5%
 - involvement of a social work/ health/ community care service, provided to 4%.

¹ The household must have been assessed as homeless or threatened with homelessness in both applications for the second application to be classed as a repeat application.

• The number of homeless households securing a permanent let in social rented accommodation increased from a little under 12,000 and 2002-03 to reach around 17,500 in 2005-06 and 2006-07 falling to around 16,300 in 2007-08. The reduction between 2006-07 and 2007-08 in the number of homeless households securing social rented accommodation reflects a reduction in the total number of homeless households whose cases were resolved in 2007-08. (See table 7)

Households in temporary accommodation

- At 31 March 2008 there were 9,518 households in temporary accommodation who had been placed there under the Homeless Persons legislation. (Table 8)
- This represents an increase of 11% compared to the situation at 31 March 2007. However, the inclusion by Glasgow for the first time of 542 previously asylum seeker households assessed as homeless overstates the underlying rate of increase in numbers in temporary accommodation. Adjusting for this gives an underlying rate of increase of 4.7% between 2006-07 and 2007-08.
- At 31 March 2008 there were 3,986 households with children or pregnant women in temporary accommodation. (Table 8)
- At 31 March 2008, 64% of households in temporary accommodation were in local authority or housing association accommodation, with a further 12% in hostels and 17% in bed and breakfast accommodation (Table 9).
- Households with children tend on the whole to be provided with local authority or housing association accommodation (87%), with a minority (3%) being placed in bed and breakfast accommodation. (Table 9)
- At 31 March 2008, there were 118 households with children or pregnant women in bed and breakfast accommodation. This varied by local authority, with 18 local authorities having none or only one household with children in bed and breakfast and 4 local authorities having more than 10. (Table 10)
- Councils with the largest number of households with children or pregnant women in bed & breakfast accommodation were Perth & Kinross (22), Highland (14) Moray (13) and Midlothian (12). (Table 10)

Implementation of the Unsuitable Accommodation Order

- A total of 62 breaches of the Order were reported at 31 March 2008; an increase from 34 breaches reported at 31 March 2007. (Table 12)
- Councils with the largest number of households housed in breach of the order were Perth & Kinross (11 households), Midlothian (10 households), Moray and Highland (9 households) and Falkirk (5 households).
- The number of breaches of the Order represents 1.6% of households with children or pregnant women in temporary accommodation at that point.

Context

- 4. In interpreting the statistics and analyses in this release, it is important to bear in mind that the information is derived from councils' administration of homelessness legislation. Trends can be affected by legislative changes, changes in interpretation of legislation or guidance and by changes in local authority recording practice. Where these have been identified, these are highlighted in the description of the main trends.
- 5. In 2001, the Scottish Parliament passed legislation which placed additional duties on councils to provide a minimum of temporary accommodation, advice and assistance to all applicants assessed as homeless. In particular, from September 2002, councils have been required to provide temporary accommodation, advice and assistance to non-priority applicants who in the past would have received advice and assistance only. This has had a noticeable impact on applications, which has been reflected

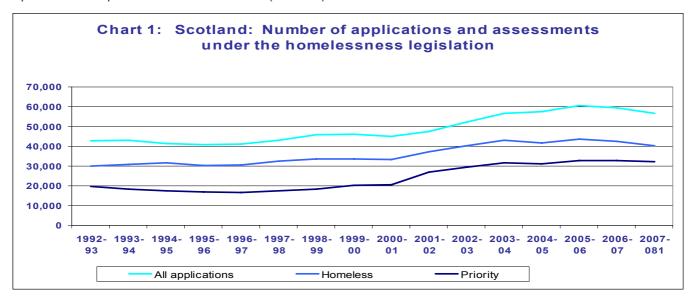
in changing assessments and outcomes for homeless people. Some tables in this release therefore present time series data so that this impact can be tracked.

- 6. The Homelessness Etc (Scotland) Act 2003 aims to ensure that by 2012 everyone assessed as being unintentionally homeless is entitled to settled accommodation. In the homelessness statistics we would generally expect to see progress towards this commitment reflected in increasing proportions of those applicants who are assessed as homeless or threatened with homelessness as also in priority need, and reducing proportions assessed as non-priority.
- 7. The Homeless Persons (Unsuitable Accommodation) (Scotland) Order came into force in December 2004. This Order requires councils to ensure that households with children or pregnant women are not placed in unsuitable temporary accommodation, unless exceptional circumstances apply. Changes in the data collection to monitor the implementation of the Order are described in the notes section before the tables.

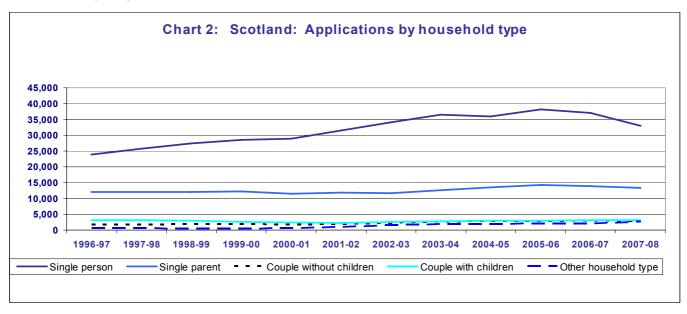
MAIN NATIONAL TRENDS

Applications

- 8. The number of applications to councils for assistance each year under the homelessness legislation, which had remained between 40,000 and 45,000 per year in the mid to late 1990s, increased rapidly from 2000-01 to a high point of about 60,500 in 2005-06. Changes in duties to provide temporary accommodation to all those assessed as homeless and the expectation that higher proportions of applicants are likely to be assessed as priority need in order to meet the 2012 commitment are likely to have encouraged applications from households who previously would have received advice and assistance only.
- 9. The most recent figures indicate that that, for Scotland as a whole, numbers applying for assistance, which levelled out in 2006-07, have begun to fall. The 56,609 applications in 2007-08 represent a drop of 4.9% over 2006-07 (Chart 1).

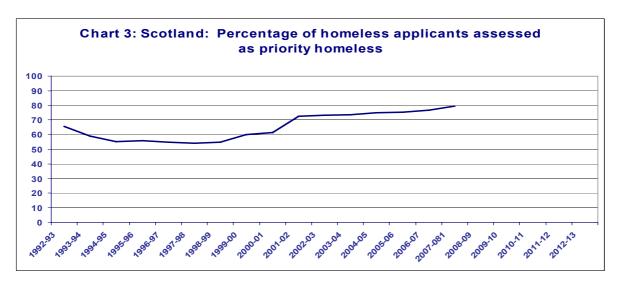


10. In recent years, the observed increases in levels of applications have primarily been due to the increase in the numbers of single-person households applying, together with a more modest increase in applications from single parents (Chart 2). Legislative change is likely to have been an important driver of this increase as single applicants have benefited most from the changes. However, some of the increase may also reflect wider social change with increasing proportions of young people living independently as well as an increase in the rate of household dissolution following breakdown of relationships. The reduction in applications since 2005-06 is also mainly due to a reduction in applications by single person households.



Assessments

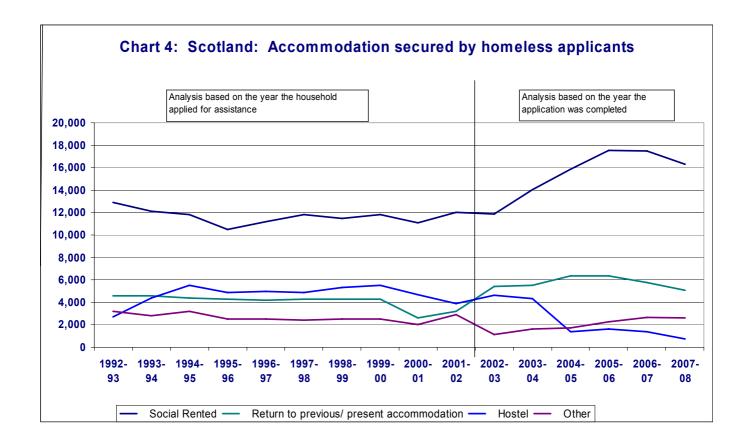
11. Of the 56,609 applications in 2007-08 40,299 were assessed as homeless or potentially homeless, 32,111 were assessed as priority and 1,677 had yet to be assessed at the time of the analysis. (Chart 1 and Table 1). Those with a priority assessment represent 79.7% of those assessed as homeless. This is a 3.0 percentage points increase over 2006-07 which in turn was a 1.2 percentage points increase over 2005-06. (chart 1 and table 3). The proportion of homeless households assessed as priority measures progress against national indicator 28 – "All unintentionally homeless households will be entitled to settled accommodation by 2012"³.



Outcomes

12. As a consequence of the increasing numbers of households assessed as priority, the number securing permanent accommodation has increased markedly since 2001-02 while the number securing hostel accommodation has fallen. (See chart 4 and table 7). The number of homeless households securing a permanent let in social rented accommodation increased from a little under 12,000 and 2002-03 to reach around 17,500 in 2005-06 and 2006-07 falling to around 16,300 in 2007-08. The reduction between 2006-07 and 2007-08 in the number of homeless households securing social rented accommodation reflects a reduction in the total number of homeless households whose cases were resolved in 2007-08. (See table 7)

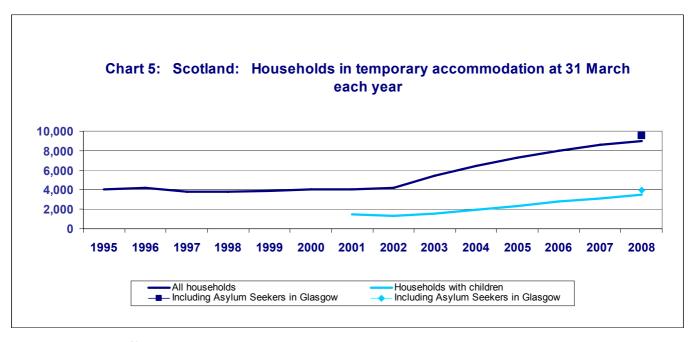


Temporary accommodation

- 13. Homeless applicants may be placed in temporary accommodation while the council assesses their application or while awaiting the offer of a permanent let. Also, non-priority applicants and those assessed as intentionally homeless may be placed in temporary accommodation as the outcome of their application.
- 14. Mainly reflecting the increase in applications since 2001-02, there has been a marked and consistent increase in the number of households in temporary accommodation from around 4,000 at 31 March 2002 to around 9,000 at 31 March 2008⁴. (Chart 5). The number of households with children in temporary accommodation has also increased since 2002, and these households currently represent about two fifths (42%) of all households in temporary accommodation.

⁴ In early 2008 Glasgow council accepted around 646 asylum seekers as homeless applicants. This reflects the review undertaken by the Home Office of failed asylum seeker cases which had previously been given leave to remain. A number of these households have now had positive decisions, chosen to stay in Glasgow and have made homeless applications. In March 2008, 542 of these households were in temporary accommodation, and of these, 522 were households with dependent children or a household member pregnant. Chart 4 shows the break in comparability with the previous series.

Figures for households with children or pregnant women are not strictly comparable prior to June 2005 as previous figures did not include households with pregnant women and no children.

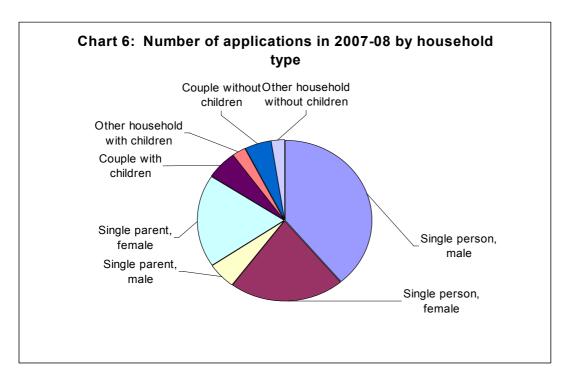
542 of the 9,518 households in temporary accommodation on 31 March 2008 were asylum seekers in Glasgow who have not previously been included in the homelessness statistics. 522 of these were households with dependent children.

Numbers in temporary accommodation in North Ayrshire from 31 March 2003 have been revised significantly downwards since previous publications to correct for previous misreporting. See paragraph 30 for a full explanation of the revisions.

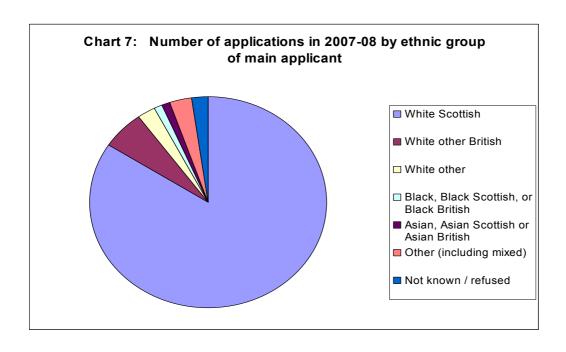
KEY FEATURES OF APPLICATIONS AND OUTCOMES

Characteristics of applicants

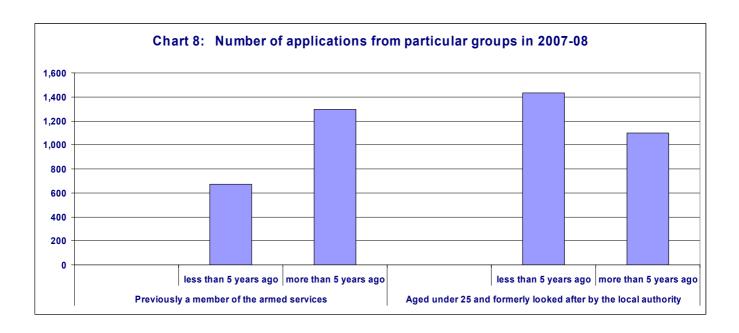
15. Of the 56,609 applications for assistance in 2007-08, around 34,000 (60%) were single people of whom almost 22,000 were men and 12,000 were women. (See chart 6 and table 3). Just under 18,300 applications (30% of applications) were from households with children, most of whom were single parent households - (24% of all applications).



16. In 92.6% of applications in 2007-08 the main applicant was recorded as White, 1.0% were recorded as Black, Black Scottish or Black British, 1.1% were recorded as Asian, Asian Scottish or Asian British and 3.0% as in other ethnic groups. An ethnic group was not recorded for 2.3% of all applicants. (Chart 7). Also, in 2007-08, 474 applicants described themselves as a gypsy/ traveller. However, it is important to note that no response was given to this question for 2,797 applicants in 2007-08, so the number of gypsy/ travellers applying for assistance may be understated slightly.



17. In 2007-08, 1,968 homeless applicants had previously been in the armed forces. Of these, 671 had been in the armed forces less than 5 years ago and 1,297 more than 5 years ago. In the same period, 2,531 applicants aged under 25 had been formerly looked after by the local authority. This represents about 6% of all applicants aged under 25. (See chart 8).



Prior circumstances of applicants and reasons for homelessness

- 18. Of the 56,609 applications for assistance in 2008-09, 24,044 (42%) had been living with friends and relatives while 19,989 (35%) had been living in their own accommodation (i.e. which they either rented or owned), 1,938 (3%) had come from prison and 1,438 (3%) had come from supported accommodation. (See table 3). Of those who had been in their own accommodation, 7,801 were in social rented accommodation, 7,488 were renting privately, 472 had been in a tenancy secured through employment and 4,228 were owner occupiers.
- 19. Of the 4,228 applicants who had been owner occupiers, 1,106 a little over a quarter cited financial difficulties/ debt or unemployment as a contributory reason to their loss of accommodation. For those previously renting socially or privately, external factors such as landlord selling the property, harassment by others or changes in household circumstances were most likely to be given as reasons for loss of accommodation. (See chart 9). For the 14,652 applicants previously staying with friends or relatives, external factors were cited as the main reason for loss of accommodation with lack of support from friends or family also a significant factor cited by 2,656 (18%). (See chart 10).

Chart 9: Reason for loss of accommodation by previous housing circumstances: Households coming from their own property

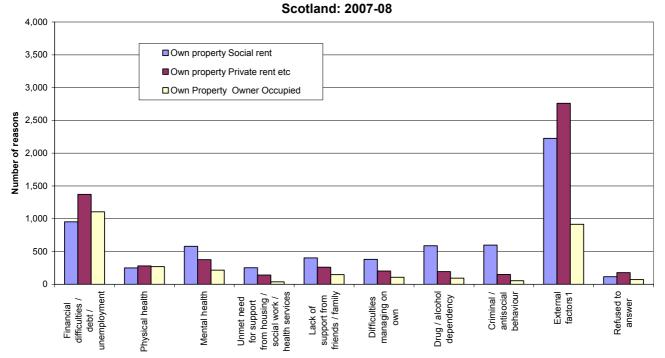
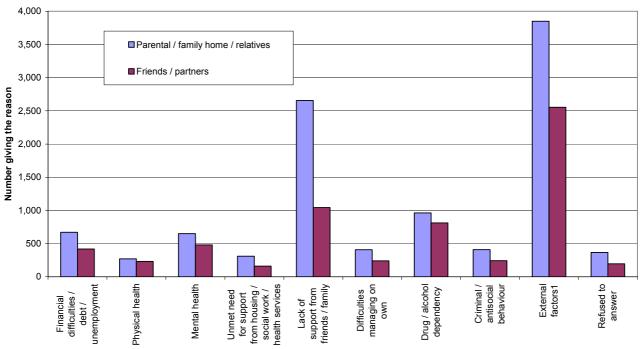


Chart 10: Reason for loss of accommodation by Previous housing circumstances

20. In 2007-08 the main reason for applying, given by a quarter of all applicants (14,007 of the 56,609 applications in the period) was that they were asked to leave their present accommodation. Other specific reasons were non-violent dispute/ relationship breakdown given by 9,291 (16%) applicants, A violent or abusive dispute within the household 5,865 (10%) of applications, and action by a landlord resulting in termination of tenancy 4,549 (8%). (See Chart 11 and Table 5).

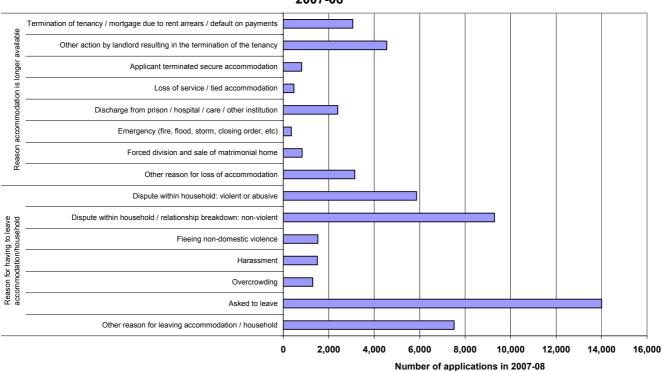
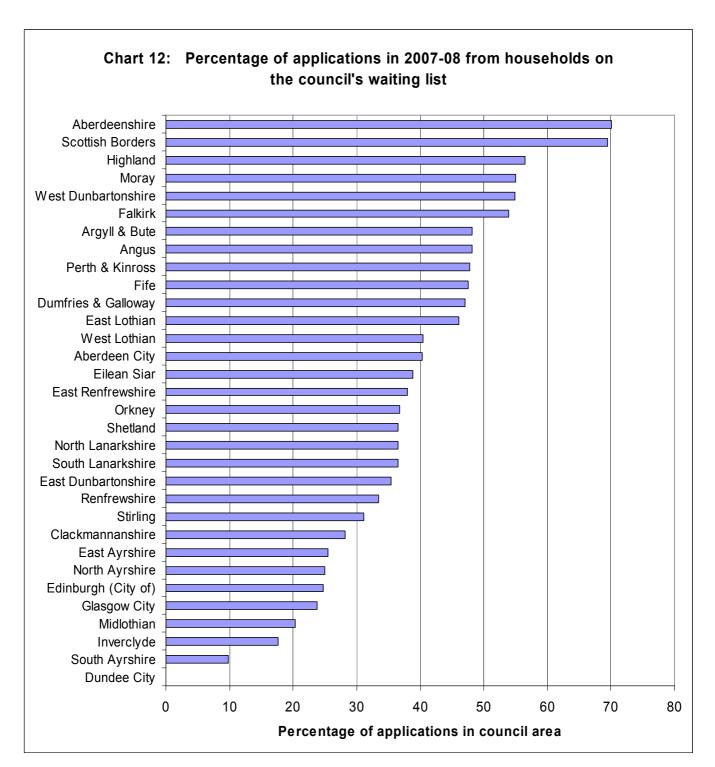


Chart 11: Main reason for applying for assistance: All applications: Scotland: 2007-08

21. In 2007-08 36% of homelessness applications were from households on the council's waiting list. This proportion varied widely between councils from around 70% in Aberdeenshire and Scottish Borders, to around 10% in South Ayrshire. (See Chart 12) This question was asked for the first time in 2007-08, so there may be some under-reporting in some council areas⁵.

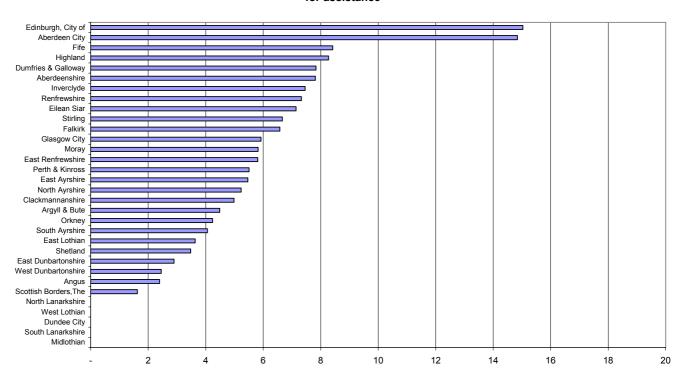


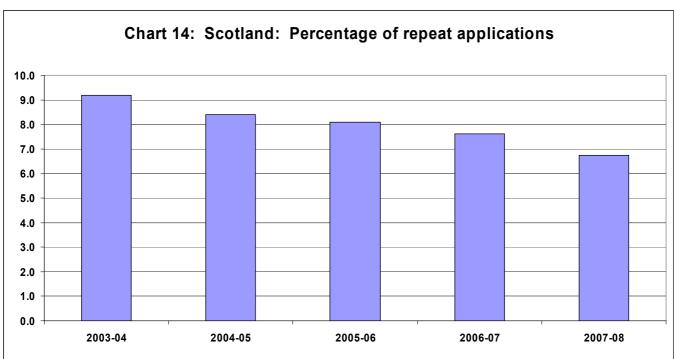
- 22. In 2007-08 6% of applicants 282 applicants per month had slept rough the night before applying for assistance. The incidence of rough sleeping among homeless applicants was highest in Edinburgh and Aberdeen (around 15% of applicants in 2007-08) while less than 1% of applicants were recorded as sleeping rough the night before application in North Lanarkshire, West Lothian, Dundee, South Lanarkshire and Midlothian. (See Chart 13).
- 23. The percentage of homeless applications identified as repeat applications (i.e. where a previous application from the household had been closed less than 12 months before the current application⁶) has fallen from 9.2% in 2003-04 to 6.7% in 2007-08. (Chart 14) Single men are much more likely than any other household group to apply for assistance more than once.

The chart shows for each year the percentage of assessments where the applicant household was assessed as homeless or threatened with homelessness, had previously applied and been assessed as homeless or threatened with homelessness and whose previous application had been closed within 12 months of their current application.

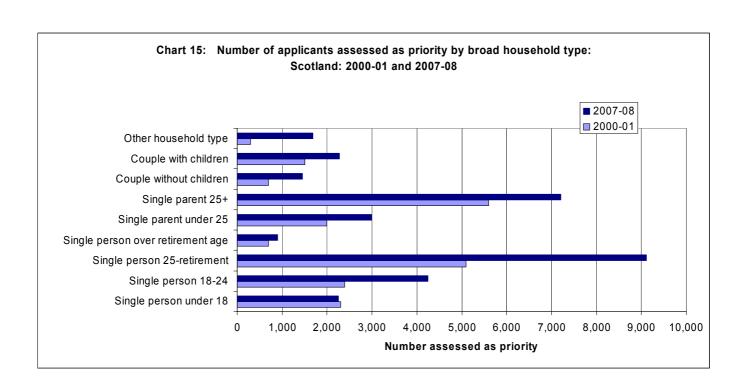
Assessments

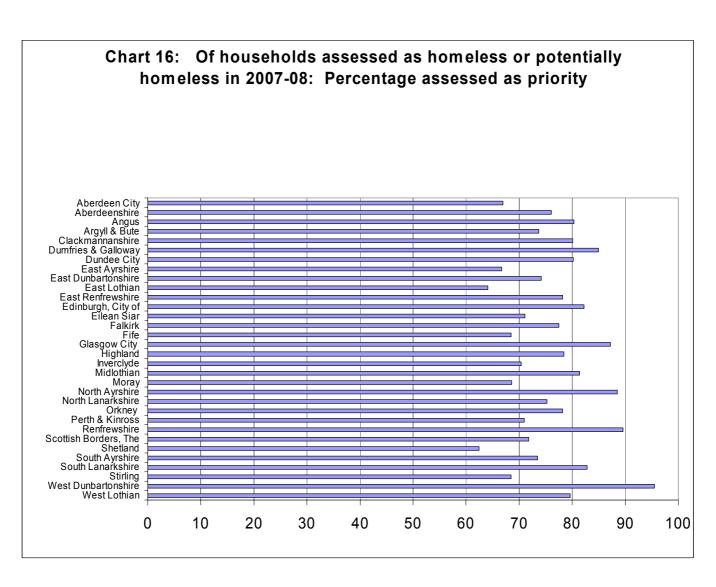
- 23. Table 1 provides the main summary statistics on the progress of homelessness applications. analysed by the year in which the application was received by the council. The year of application is also the basis by which we measure progress against national indicator 28 - "All unintentionally homeless households will be entitled to settled accommodation by 2012"7. However, it takes time for councils to assess a homelessness application. As a consequence, 1,677 applications in 2007-08 have yet to be assessed. In order to provide a clearer picture of patterns of assessment this section of the report presents analyses of assessments based on the year the assessment was made, rather than the year of application.
- In 2007-08, councils assessed 40,649 applications as either homeless or threatened with homelessness⁸. Of these, 32,287 (79.4%) were assessed as priority⁹. The proportion of those assessed as homeless/ threatened with homelessness who are also assessed as priority has increased in each year since 2000-01 as councils have progressed towards the 2012 homelessness commitment. Over the period all households with children have been assessed as priority and the main impact of the commitment has been that increasing numbers and proportions of other, mainly single person households have been assessed as priority. Chart 14 shows the impact of these changes on the number and characteristics of priority households. In 2000-01, the largest group in priority need were single parent households with parent aged 25 or over. By 2007-08 single people aged between 25 and retirement were the largest priority group, their numbers having increased from a little over 5,000 in 2000-01 to over 9,000 in 2007-08.
- 25. The proportion of homeless households assessed as priority in 2007-08 varies widely between councils, from 96% in West Dunbartonshire to under 70% in Moray, Fife, Stirling, Aberdeen City, East Ayrshire, East Lothian and Shetland. (Chart 16)
- Of the 40,649 households assessed as homeless in 2007-08 13,711 (34%) were assessed as having one or more support needs. (Table 6 and Chart 17) A higher proportion of applicants in priority need (40%) were assessed as having one or more support needs. Of those with support needs 4,769 (12% of all assessed as homeless) required support because of mental health, 4,487 (11%) required support on skills for independent living, and 4,197 (10%) required support because of alcohol or dependency problems.
- For applicants assessed as priority councils record reasons why the household has priority. Councils must identify at least one reason for the priority assessment, but more than 1 reason can be given. In 2007-08, the main reasons for priority assessment were that the household had dependent children (39% of all priority assessments), the household was fleeing domestic violence or abuse (14%), mental illness or personality disorder of a household member (12%) and a household member vulnerable for other special reasons. (Chart 18)

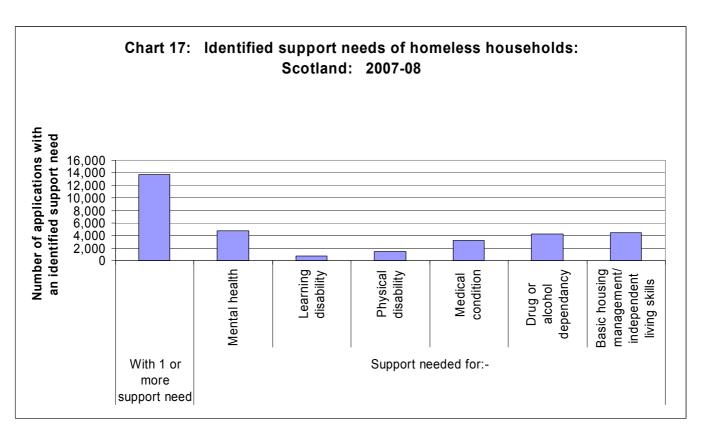

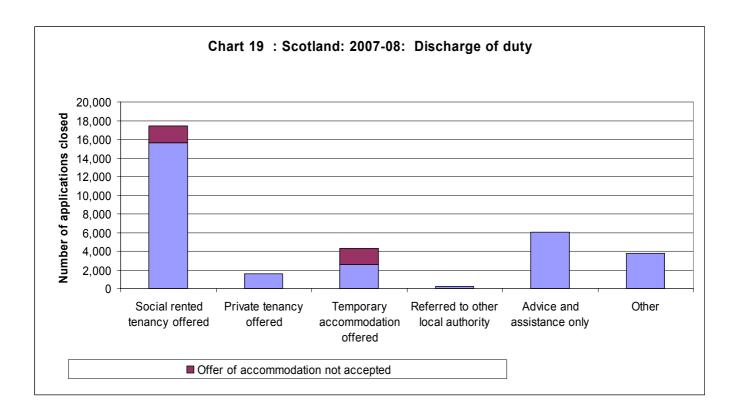






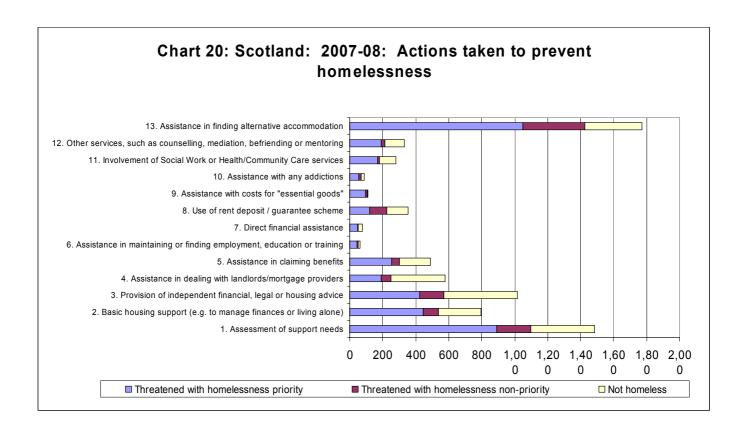
Outcomes

27. In 2007-08 councils closed 51,476 cases. Of these, 10,835 were cases in which the application had been withdrawn, or contact lost with the applicant before an assessment could be made. Contact was lost before the council discharged its duty in a further 7,209 cases. Chart 17 shows the offers of accommodation and outcomes for the remaining 33,432 applications where contact was maintained through to completion of the application. Of these, 17,447 households were offered a social rented tenancy, most of whom 15,598 (89% of those offered a social tenancy) took up the offer; temporary accommodation was offered to 4,289 households of whom 2,551 (59%) took up the offer; and a private rented tenancy was offered to 1,573 households almost all of whom (99%) accepted the offer. (chart 19)

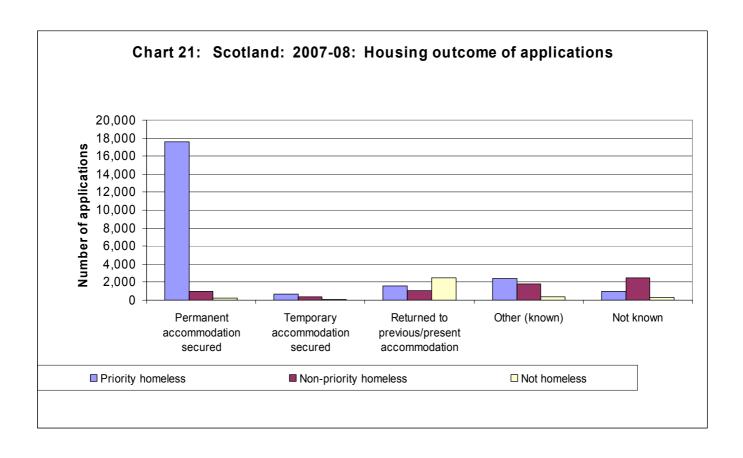


28. A new question introduced from 1 April 2007 asks councils, at the time they close an application to identify action they took to prevent homelessness for households assessed as threatened with homelessness or assessed as not homeless. Councils can record more than one prevention activity for each application. Chart 20 shows prevention actions taken for the 6,383 households who applied in 2007-08, were assessed as threatened with homelessness or not homeless and whose case was closed in 2007-08 and for which councils supplied this information¹⁰. Of these, 1,770 (28%) were provided with assistance in finding alternative accommodation, 1,486 (23%) were provided with an assessment of their support needs, 1,016 (16%) received independent financial, legal or housing advice, 794 (12%) received basic housing support, 578 (15%) received assistance in dealing with their landlord or mortgage provider, 490 (8%) had assistance in claiming benefits 354 (6%) were assisted to use a rent deposit/ guarantee scheme, for 331 (5%) services such as counselling or mediation were provided and for 280 households (4%) a Social Work/ Health/ or Community Care service was involved.

29. In 2007-08, permanent accommodation was secured for 18,759 of the 33,432 applications where contact was maintained through to completion of the application. (See chart 21). Within this, 17,562 priority homeless applicants (75% of priority homeless) secured permanent accommodation, 956 non-priority homeless (14% of non-priority homeless) and 241 who were assessed as not homeless (7% of those not homeless) secured permanent accommodation. For 2,515 (37%) of the 6,757 non-priority homeless the authority did not know the type of accommodation taken up by the applicant following discharge of the council's duty. Other known outcomes include those who moved in with friends or relatives and those obtaining a tenancy with a voluntary organisation.



Temporary accommodation

- 30. Statistics on numbers of households in temporary accommodation are taken from a quarterly statistical return by councils¹¹. The return provides summary information on households in temporary accommodation at the end of the quarter who have been placed there as a consequence of their homelessness application. Homeless applicants may be placed in temporary accommodation while the council assesses their application or while awaiting the offer of a permanent let. Also, non-priority applicants and those assessed as intentionally homeless may be placed in temporary accommodation as the outcome of their application.
- 31. In interpreting the statistics presented in this report the following points should be noted:-
 - Up to March 2005 the summary information on households in temporary accommodation separately identified households with children from households without children. From June 2005 those households without children where a household member was pregnant have been grouped with households with children. This change will have led to a minor break in comparability in the time series.
 - Following publication of the 2006-07 annual homelessness bulletin, North Ayrshire revised its figures on numbers of households in temporary accommodation downwards to correct an error in the way in which the council was recording these. Essentially the council had, from 2002, been reporting numbers of households placed in temporary accommodation during the quarter rather than the number remaining in temporary accommodation at the end of the quarter. Adjusted figures from 2005 were published in the April 2008 homelessness publication. This publication includes revised national totals reflecting revised North Ayrshire estimates from 2002.
 - In early 2008 Glasgow council accepted around 646 asylum seekers as homeless applicants. This reflects the review undertaken by the Home Office of failed asylum seeker cases which had previously been given leave to remain. A number of these households have now had positive decisions, chosen to stay in Glasgow and have made homeless applications. In March 2008, 542 of these households were in temporary accommodation, and of these, 522 were households with dependent children or a household member pregnant. Inclusion of these households in numbers in temporary accommodation on 31 March 2008 overstates the underlying rate of increase in numbers in temporary accommodation when compared with March 2007.
- 32. At 31 March 2008 there were $9{,}518$ households in temporary accommodation, having been placed there under the Homeless Persons legislation, of whom $3{,}986$ (42%) were households with children. (Table 8)
- 33. The number of households in temporary accommodation has increased in each year from March 2002. This increase has been driven both by the increase in applications and by the new duties placed on councils since September 2002. Although the numbers continue to rise, the longer term data indicate that, after adjusting for the discontinuity in the Glasgow data, there is a continuing gradual reduction in the underlying rate of increase from a 30% increase between March 2002 and March 2003 reducing to an adjusted underlying 4.7% increase between March 2007 and March 2008. (Table 9 and Chart 4).
- 34. At 31 March 2008 42% of households in temporary accommodation were households with children or with a pregnant household member. This is notably higher than the 36% share at 31 March 2007 and a low of 30% in March 2003. While the inclusion of asylum seekers by Glasgow in 2007-08, most of whom were households with children, has affected the comparison, nevertheless there is a clear upwards trend in this proportion¹².

The increase between March 2005 and March 2006 will also have been affected to some extent by the inclusion of households where a household member is pregnant in this grouping. See paragraph 31.

- 35. The majority of households in temporary accommodation were in local authority or housing association accommodation (64%), with a further 12% in hostels and 17% in bed and breakfast. (See Tables 8 & 9). Households with children or pregnant women are mainly provided with local authority or housing association accommodation (87%), with a small proportion (3%) being placed in bed and breakfast accommodation.
- 35. On 31 March 2008, there were 118 households with children or pregnant women in bed and breakfast accommodation. This varied by local authority, with 14 local authorities having none or only one household with children in bed and breakfast, and four local authorities having more than ten.
- 36. Councils with the largest number of households with children or pregnant women in bed & breakfast accommodation were Perth & Kinross (22), Highland (14) Moray (13) and Midlothian (12).

Implementation of the Unsuitable Accommodation Order

- 37. For each quarter from June 2005, councils have reported on the number of households at the end of the quarter in temporary accommodation which was in breach of the Unsuitable Accommodation Order. The snapshot figures show:
 - Fourteen councils reported breaches of the order on 31 March 2008, affecting 62 households, this shows an increase from 34 reported breached at 31 March 2007.
 - The 62 households whose accommodation breached the order comprised 1.6% of all households with children or pregnant household member in temporary accommodation at 31 March 2008.
 - Councils with the largest number of households housed in breach of the order were Perth & Kinross (11 households), Midlothian (10 households), Moray and Highland (9 households) and Falkirk (5 households).

NOTES ON TABLES

- 1. The statistics presented in this release relate to applications made under the legislation as well as individual households. Given the continuous nature of the recording system, figures are updated on an on-going basis and may differ from those previously published.
- 2. The data presented in these tables are based on the time period relevant to the analysis. In some cases this might be the year of application, while in others this might relate to the year in which the assessment was made or action taken. All years refer to financial years.
- 3. To facilitate comparisons between authorities, some of the local authority tables are presented in the form of percentages. However, where the number of applications is small the percentage figures should be treated with caution.
- 4. Unless otherwise stated, the assessment category of 'homeless' includes both homeless and those threatened with homelessness, as well as unintentional and intentional homeless. Although the focus of the current legislative changes is on providing settled accommodation to those assessed as unintentionally homeless, the proportion of applications assessed as intentionally homeless and in priority need is relatively small. This category has therefore been combined with that of unintentionally homeless and in priority need for the more complex analyses.
- 5. In December 2001, the Scottish Executive changed the data collection system for the case-based HL1 return to provide more detailed information on applications by individual households and to allow more timely reporting. This entailed changing to an electronic data capture system which allows cases to be registered and updated on a continuous basis, as well as enabling applications made by the same household to be linked.
- 6. The data collection system introduced in December 2001 allows analysis by individual households and the identification of repeat applications. However, this is not the case for earlier data and so analyses comparing data over time will tend to refer to applications rather than individual households. This is also the case for analyses of flow through the assessment process where repeat applications by the same individual household might be assessed differently and have different outcomes. For other analyses it is useful to distinguish individual households and so the unit of analysis (applications or individual households) is specified in the footnotes for each table.
- 7. The data collection was further revised in April 2007 in the light of the Homelessness etc. (Scotland) Act 2003, with some additional information included to reflect current best practice. Further information on the HL1 can be found at http://www.scotland.gov.uk/Topics/Statistics/15257/HL1revisions.
- 8. The figures on households in temporary accommodation relate to households which have been placed in temporary accommodation by a local authority under the Homeless Persons legislation. This will include households for whom the local authority's decision and final action is still pending, as well as households which were secured such accommodation as a final action by the authority under the legislation. The data provide a snapshot picture of the numbers in temporary accommodation as at the last day of each quarter and are collected in the summary HL2 return.
- 9. Hostels, as temporary accommodation under the homeless persons legislation, were used mainly by Glasgow. In fact, almost all households in hostels in Glasgow were placed there by the authority under the Homeless Persons legislation. In other authorities, particularly in the cities, there are many households in hostels that have not been placed there by the local authority under the Homeless Persons legislation. Consequently, they are not recorded in the statistics.
- 10. In June 2005, the HL2 return was revised in order to monitor the implementation of the Homeless Persons (Unsuitable Accommodation) (Scotland) Order 2004. The revised return records the number of households with children or pregnant women in temporary accommodation as at the end of the quarter, the number of those in unsuitable accommodation as defined by the Order, and the number of those in accommodation which breaches the Order. Not all use of unsuitable accommodation is in breach of the Order as such use may be allowed under exceptional circumstances as defined in the Order (see summary of legislation below), and therefore the focus of this release is on actual breaches rather than all instances of use of unsuitable accommodation where exceptions may apply. The latter figure provides a useful process measure to assess implementation in practice. To put the figures into the context, as at

30 June, 30 September and 31 December 2007 there were respectively 103, 81 and 58 instances of use of unsuitable accommodation. On the whole, the Order was actually breached in around half of cases.

SUMMARY OF CURRENT LEGISLATION

- 13. The Housing (Homeless Persons) Act 1977, now consolidated into Part II of the Housing (Scotland) Act 1987, introduced statutory duties on housing authorities to assist those who are homeless or threatened with homelessness (potentially homeless), including providing accommodation in certain circumstances.
- 14. The legislation currently requires local authorities to make inquiries into the circumstances of applicants to satisfy themselves whether the applicant is homeless or potentially homeless. Once the authority is satisfied this is the case, it must also determine whether the applicant has a priority need, whether he/she became homeless intentionally and, in some cases, whether the applicant has a local connection with another authority in Scotland, England or Wales. A local connection with an authority means that the applicant normally resided in that area from choice, either because he/she was employed in or had family associations with it, or for other special reasons.
- 15. Section 24 of the Housing (Scotland) Act 1987, as amended, defines homelessness for the purposes of the Act as follows. A person is homeless if he/she has no accommodation in the UK or elsewhere. A person is also homeless if he/she has accommodation but cannot reasonably occupy it, for example because of a threat of violence. A person is potentially homeless (threatened with homelessness) if it is likely that he/she will become homeless within two months. A person is intentionally homeless if he/she deliberately did or failed to do anything which led to the loss of accommodation which it was reasonable for him/her to continue to occupy.
- 16. Section 25 of the Housing (Scotland) Act 1987, as amended, defines the categories of household regarded as having a priority need for accommodation. Further details can be found in the Code of Guidance on Homelessness. This is available on-line at: http://www.scotland.gov.uk/Publications/2005/05/31133334/33366.
- 17. The Housing (Scotland) Act 2001 amends the 1987 Act and requires councils to provide a minimum of temporary accommodation, advice and assistance to all applicants assessed as homeless, regardless of whether they have been assessed as being in priority need. The Homelessness Etc (Scotland) Act 2003 is more long-term in scope, notably introducing a phasing out of the distinction between priority and non-priority applications, and enabling the suspension of the test of local connection. The ultimate aim of the Act is to ensure that everyone assessed as being unintentionally homeless is entitled to settled accommodation by 2012.
- 18. The Homeless Persons (Unsuitable Accommodation) (Scotland) Order 2004 came into force on 6 December 2004, and is intended to prevent the routine use of unsuitable temporary accommodation for households with family commitments. Under this Order, local authorities cannot put households with children and pregnant women into temporary accommodation which is not suitable, unless exceptional circumstances apply. Unsuitable accommodation is defined in the Order as accommodation which does not meet standards relating to the physical properties of the accommodation (the physical standard), its proximity to health and education services (the proximity standard) and its suitability for use by children (the safety standard).
- While the Order provides for exceptional circumstances in which accommodation which does not 19. meet the physical and/or proximity standards may be used, the safety standard must always be met.
